## Introduction

This E-Mail ALSPO message updates the procedures for entering reenlistment contracts for active duty members authorized to enter into a new indefinite reenlistment for the purpose of selling leave and for members who have 10 or more years of active service.

## **Discussion**

Reference (a) announced two policy changes to the indefinite reenlistment program:

- 1. Members who are currently serving on an indefinite reenlistment contract are authorized to enter into a new indefinite reenlistment, one time, during a career for the purpose of selling leave.
- 2. Members who have 10 or more years of active service will be allowed to reenlist for periods of three years, four years, five years, six years or for an indefinite period up to their 30-year active duty anniversary date.

#### Effective date

The policy changes, announced in reference (a), are effective 1 September 2008.

Direct-Access software and procedural changes, described herein, are effective 2 September 2008. If a reenlistment contract is needed for a reenlistment ceremony (on 1 or 2 September), the SPO can produce a contract for the member and enlisting officer to sign using the template available at: <a href="http://www.uscg.mil/hr/psc/da/dd4.doc">http://www.uscg.mil/hr/psc/da/dd4.doc</a>. The data entry can be completed after the software changes are effective.

# Subj: INDEFINITE REENLISTMENT PROGRAM CHANGES

Procedural/ software change for members who have 10 or more years of active service Members who have 10 or more years of active service were required to reenlist for an indefinite period up to the last day of the month in which the member reached their 30-year active duty anniversary date. Per reference (a), these members may, effective 1 September, elect to reenlist for a specific term (3 to 6 full years) or reenlist indefinitely.

The software edit in Direct-Access, which restricted reenlistment contracts for these members to "Indefinite Re-Enlistment" (described in Step 4 of reference (b)), will be removed and SPO users will be able to enter the number of years of the reenlistment in the "Contract Term Years" field or place a checkmark in the "Indefinite Re-Enlistment" field. The remaining steps in reference (b), for entering the reenlistment contract and, if applicable, recording leave to sell, are not changing.

Procedural/ software change for members who are currently serving on an indefinite reenlistment Direct-Access will restrict reenlistment contracts for members currently serving on an indefinite reenlistment to "*Indefinite Re-Enlistment*". The "*Reason*" field must be set to "*Request of Member*". The remaining steps in reference (b), for entering the reenlistment contract and recording leave to sell are not changing.
