Minutes March 3, 2004

Chairman Antonovich called the meeting of the Brain Tumor and Air Pollution Foundation to order at 9:07 a.m. Present by teleconference from the locations indicated were the following Directors (in alphabetical order):

1. APPROVE MINUTES OF FEBRUARY 12, 2004 and FEBRUARY 25, 2004 MEETINGS

Moved (Davidson), seconded (Antonovich) and unanimously approved. Mr. Bernsor abstained regarding the February 25, 2004 minutes since he was not present at that meeting.

2. A. AMEND ARTICLES OF INCORPORATION

This action is to amend the Articles of Incorporation to change the name of the nonprofit corporation to "Brain and Lung Tumor and Air Pollution Foundation" and to change the specific purpose of the corporation: (i) to aid, assist, and support research on the incidence, detection and causes of brain and lung tumors, especially those caused or aggravated by air pollution; and (ii) to receive and utilize funds acquired through the solicitation of donations, gifts, and bequests for the purposes for which this corporation was formed. Moved (Bernson), seconded (Antonovich) and unanimously approved.

B. AMEND BYLAWS

This action is to amend the Bylaws to reflect changes resulting from the changed named of the nonprofit corporation, to provide for recovery of royalties—or other payments from grantees—from research funded by the Foundation with monies provided by the AQMD. The amendments also make the following administrative changes: authorize the AQMD Board, as

the Foundation's member, to designate a Board member to act on the Board's behalf; provide that the Foundation's Chief Executive Officer may also be designated as its president; and provide that neither the Secretary nor Treasurer can serve concurrently as the Chief Executive Officer. Moved (Davidson), seconded (Bernson) and unanimously approved.

3. ANNUAL REPORT

Dr. Wallerstein advised that this action is to approve the annual report that will be presented to the South Coast Air Quality Management District Governing Board on March 5, 2004. The report provides a brief background of the Foundation and a summary of its Directors and Officers, a report on the Foundation's activities and plans, and a financial report. Moved (Bernson), seconded (Davidson) and unanimously approved.

4. RECOMMENDATION TO MAKE INVESTMENT

The following materials were faxed to the Board Members on March 2, 2004:

- (1) eleven-page letter from Best, Best & Krieger to Board of Directors, Brain Tumor and Air Pollution The (sic) Foundation dated March 1, 2004 (hereinafter "Opinion Letter") and
- (2) two-page Memorandum from Best, Best & Krieger to Board of Directors, Brain Tumor and Air pollution Foundation dated March 2, 2004 (hereinafter "Opinion Memorandum").

It was ascertained that each Board Member had both the Opinion Letter and the Opinion Memorandum in their possession.

Kurt Wiese reported that it would be staff's recommendation to not purchase stock in MicroSurgeon, Inc., but rather fund a research grant with limitations described in Dwight Montgomery's Opinion Memorandum, and with the Foundation to receive royalties and/or intellectual property rights.

Mr. Bernson suggested the Foundation Board authorize staff to begin negotiating with MicroSurgeon regarding a research grant as outlined by Mr. Wiese. Dwight Montgomery, Esq. of the law firm of Best, Best & Krieger advised that research grants are a common practice between nonprofit and for-profit organizations. Stock acquisition would violate both government law regarding government agencies and tax law regarding nonprofit entities.

Mr. Bernson indicated there ought to be specification that any proceeds must be used to further advance the goals of the Foundation. Mr. Wallerstein pointed out that the AQMD Board's intent in granting the \$1.5 million to the Foundation was to have proceeds go back to the AQMD, which will decide how to allocate those proceeds.

In response to concerns about getting further opinions, Mr. Montgomery indicated the Foundation could request a letter ruling from Franchise Tax Board and the Internal Revenue Service, a process that can take 6-9 months and cost thousands of dollars in attorney fees. Mr. Montgomery indicated that the filing fee for IRS letter ruling is \$25,000.

Mr. Bernson asked what would be the liability to the Foundation Board if there is a problem in the future and suggested seeking guidance from the Fair Political Practices Commission (FPPC). Mr. Wiese indicated that the FPPC gives opinions on conflicts of interest.

Mr. Bernson indicated that he wanted it understood that the Foundation Board is being held harmless if there are any repercussions and any losses will be guarantied by the AQMD Board. Mr. Montgomery advised that liability is statutorily limited or eliminated to the extent

that the Foundation Board shows that it relied on the reasoned advice of professionals. This principle has been upheld on many occasions where an investment was improper but the Board took the step of hiring a good manager who just made bad decisions. The Foundation Board should be able to withstand any attack on whether it met its fiduciary obligation by virtue of the legal opinion provided by Best, Best & Krieger and the discussion in this March 3, 2004 meeting. There has been deliberation on the matter and the requested action is to begin negotiations only. Mr. Montgomery repeated that the fiduciary obligation is discharged by looking to the professionals for advice.

Mr. Davidson suggested giving the staff authority to negotiate the terms of a research grant with the limitations as outlined in the Opinion Letter and Opinion Memorandum and to get a second legal opinion. Mr. Bernson indicated that would be his motion. Seconded (Davidson) and unanimously approved.
