PROPOSED AMENDMENT TO PUHCA RULE 45
TO CREATE EXEMPTIONS FOR ROUTINE AGREEMENTS

The Commission is proposing for public comment and amendment to Rule 45 under the Public Utility Holding Company Act of 1935 proposed in a rulemaking petition submitted by The Columbia Gas System, Inc., a registered holding company. The proposed rule would create a new exemption from the present requirement of Commission authorization pursuant to a declaration for certain routine agreements in the nature of guarantees by parent companies in registered holding company systems of obligations connected to the ordinary business operations of their subsidiary companies. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
