ADMINISTRATIVE PROCEEDINGS

HUGH F. SACKETT SANCTIONED

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940 against Hugh F. Sackett, formerly associated with registered broker-dealer and investment adviser entities. Simultaneously, the Commission accepted Sackett's Offer of Settlement in which, without admitting or denying the Commission's findings, except for the finding that he was permanently enjoined by the U.S. District Court for the Southern District of California from future violations of the registration and antifraud provisions of the Securities Act of 1933 and the Exchange Act in SEC v. W. Carl Zimmerman and Hugh F. Sackett, No. 86-1846 N (CM) (SDCA), he consented to an order barring him from association with any broker, dealer, investment adviser, investment company, or municipal securities dealer, provided, however, that at the end of two years, he may apply to become so associated.

Sackett consented to the permanent injunction on which the administrative proceeding was based. The civil action arose from Sackett's participation in the offer and sale of unregistered securities in the form of limited partnership interests and debentures in approximately 70 offerings which raised over \$90 million from at least 2,500 investors.
