RULES AND RELATED MATTERS

FINAL RULE ON PROCESSING FOIA REQUESTS

The Commission issued a release finalizing its rule regarding the processing of requests made under the Freedom of Information Act. The final rule, which does not differ from interim rules published for comment on June 27, embodies amendments made by Congress in the Freedom of Information Reform Act of 1986. The rule will become effective 30 days from the date of publication in the Federal Register. (Rel. 33-6744)

INVESTMENT COMPANY ACT RELEASES

DEL NORTE FUNDING CORPORATION

An order has been issued exempting Del Norte Funding Corporation, a Delaware corporation, from all provisions of the Investment Company Act in connection with Applicant's issuance of bonds to facilitate certain leveraged lease transactions. (Rel. IC-16171 - Dec. 10)

CASH RESERVE MANAGEMENT, INC.

A notice has been issued giving interested persons until January 4, 1988 to request a hearing on an application filed by Cash Reserve Management, Inc., and certain other registered investment companies for which E.F. Hutton & Company Inc. serves as investment adviser, and SLBP Acquisition Corp., subsidiary of Shearson Lehman Brothers Holdings Inc., for an order exempting the investment companies, Hutton, and SLBP from Section 15(a) of the Investment Company Act to the extent necessary to permit Hutton to continue serving as an investment adviser to the investment companies under an interim advisory contract. HOLDING COMPANY ACT RELEASES

SYNERGY GROUP INCORPORATED; NORTHEAST UTILITIES

Notices have been issued giving interested persons until January 4, 1988 to request a hearing on an application and a proposal by the following companies filed under Release 35-24523, dated December 10: SYNERGY GROUP INCORPORATED - of Farmingdale, New York, for an exemption under Section 3(a)(3) of the Public Utility Holding Company Act of 1935; and NORTHEAST UTILITIES - a registered holding company, and Housatonic Corporation, a newly formed corporation which Northeast proposes to acquire as a wholly owned subsidiary. Northeast proposes to acquire Housatonic common stock, and to make capital contributions and/or open account advances to Housatonic through December 31, 1992. Housatonic proposes to acquire a 17% undivided general partnership

interest in the Iroquois Gas Transmission System (Iroquois Partnership), which will engage in the transportation of natural gas, through a new pipeline system extending from the U.S.-Canada border, for distribution of gas to companies located in Connecticut, including Northeast's wholly owned operating subsidiary, The Connecticut Light and Power Company, New York and New Jersey. Housatonic proposes to borrow funds from commercial banks and/or other lending institutions, to make payments to the Iroquois Partnership and to enter into a service agreement with Northeast Utilities Service Company, Northeast's subsidiary.

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING SOUGHT

Notices have been issued giving interested persons until January 6, 1988 to comment on the applications of the Midwest Stock Exchange for unlisted trading privileges in the specified number of issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system: 30 and three issues [two separate applications]. SELF-REGULATORY ORGANIZATIONS

SUMMARY EFFECTIVENESS OF AMENDMENTS, ORDER WITHDRAWING AMENDMENTS

On December 7 participants in the Consolidated Tape Association (CTA) and the Consolidated Quotation System (CQS) submitted amendments to the CTA and CQ Plans' Network B fee schedules under Rule 11Aa3-2(c)(4). The Commission granted temporary summary effectiveness to the amendments for 120 days. The Commission also ordered withdrawn amendments to the Plans that were submitted on August 12. (Rel. 34-25193)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The MBS Clearing Corporation filed a proposed rule change which has become immediately effective. The proposal (SR-MBS-87-10) extends MSBCC's physical withdrawal procedures for an additional 60 days. (Rel. 34-25194)

TRUST INDENTURE ACT RELEASES

OHIO EDISON COMPANY

An order has been issued under the Trust Indenture Act of 1939 on an application by Ohio Edison Company that the trusteeship of Irving Trust Company under 15 Ohio indentures is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify the Bank from acting as trustee under any of these indentures.
