COMMISSION MEETINGS

Following is a schedule of Commission meetings which will be conducted under provisions of the Government in the Sunshine Act. Otherwise, meetings will be scheduled according to the requirements of agenda items under consideration.

Meetings will be held in the Commission Meeting Room, Room 1C30, at the Commission's headquarters building, 450 Fifth Street, N.W., Washington, D.C. Persons wishing to photograph or videotape Commission meetings must obtain permission in advance from the Secretary of the Commission. Persons wishing to tape record a Commission meeting should notify the Secretary's office 48 hours in advance of the meeting.

OPEN MEETING - WEDNESDAY, FEBRUARY 8, 1995 - 10:00 A.M.

The subject matter of the open meeting scheduled for Wednesday, February 8, 1995, at 10:00 a.m., will be:

The Commission will consider the adoption of proposed Rules 18f-3 and 6c-10 under the Investment Company Act of 1940, and related rule and form amendments. Rule 18f-3 would allow mutual funds to issue multiple classes of shares, and form amendments would prescribe prospectus disclosure requirements for multiple class and master-feeder funds. Rule 6c-10 would allow mutual funds to impose back-end loads, including contingent deferred sales loads; the form amendment would clarify that prospectus disclosure requirements for deferred sales loads apply to all types of back-end loads.

The Commission also will consider proposing for public comment amendments to Rule 6c-10 to allow mutual funds to impose sales loads paid in one or more installments. Related form amendments would prescribe prospectus disclosure requirements for installment loads. For further information, please contact Karrie McMillan at (202) 942-0695 (Rule 18f-3) or Nadya B. The Commission will consider whether to approve proposed rule changes by the American Stock Exchange, Inc., Chicago Board Options Exchange, Incorporated, Chicago Stock Exchange, Incorporated, Municipal Securities Rulemaking Board, National Association of Securities Dealers, Inc., New York Stock Exchange, Inc., Pacific Stock Exchange Incorporated, and Philadelphia Stock Exchange, Inc. adopting a continuing education requirement for registered persons. INVESTMENT COMPANY ACT RELEASES

G.T. GLOBAL GROWTH SERIES, ET AL.

A notice has been issued giving interested persons until February 21 to request a hearing on an application filed by G.T. Global Growth Series, et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order would permit certain investment companies to issue multiple classes of shares representing interests in the same portfolios of securities and assess, and under certain circumstances waive, a contingent deferred sales charge on redemptions of shares. (Rel. IC-20867 - January 27)

FRANKLIN GOLD FUND, ET AL.

A notice has been issued giving interested persons until February 24 to request a hearing on an application filed by Franklin Gold Fund, et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order would permit certain investment companies to issue multiple of classes of securities representing interests in the same portfolio and assess and, under certain circumstances, waive a contingent deferred sales charge (CDSC) on certain redemptions of shares. The order also would supersede an existing CDSC order. (Rel. IC-20868 - January 30)

ABT GROWTH AND INCOME TRUST, ET AL.

The order would permit Dreyfus International Equity Allocation Fund, a series of The Dreyfus/Laurel Funds, Inc. to acquire all of the assets of Dreyfus/Laurel International Fund, a series of The Dreyfus/Laurel Investment Series. HOLDING COMPANY ACT RELEASES

SYSTEM FUELS, INC., ET AL.

A supplemental order has been issued authorizing System Fuels, Inc. (SFI), a fuel procurement subsidiary company, together with its parent

companies Arkansas Power & Light Company, Louisiana Power & Light Company, Mississippi Power & Light Company, and New Orleans Public Service Inc., each an electric public-utility subsidiary company of Entergy Corporation, a registered holding company, to extend SFI's existing revolving credit agreement (Credit Agreement) for no more than \$20 million at any one time outstanding with Bank of America National Trust and Savings Association through January 31, 1996. Jurisdiction is reserved over any extension of the Credit Agreement beyond January 31, 1996. (Rel. 35-26224)

The Commission granted accelerated approval to proposed rule changes (SR-NYSE-94-48 and SR-PSE-94-37) filed by the New York Stock Exchange and the Pacific Stock Exchange, which amend the Exchanges' rules to allow members to maintain options customer information and account statements at a location other than the principal supervisory office if the documents and information are readily accessible and promptly retrievable.
