ENFORCEMENT PROCEEDINGS

JUDGMENTS ENTERED AND ADMINISTRATIVE SANCTIONS IMPOSED AGAINST VINCENT MAYER

The Commission announced the entry of a final judgment of permanent injunction and other relief against Vincent A. Mayer. The judgment enjoins Mayer from further violations of Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 thereunder, orders disgorgement, and notes the appropriateness of civil penalties under the Insider Trading Sanctions Act of 1984.

The Commission alleged that Mayer engaged in illegal insider trading in Anchor Glass Container Corporation stock prior to the announcement of a tender offer for the stock. Mayer consented, without admitting or denying the allegations, to the entry of the judgment. Payment of disgorgement was waived and penalties were not imposed based upon Mayer's demonstrated inability to pay.

Mayer also consented to the entry of an order instituting administrative proceedings against him pursuant to Section 15(b) of the Exchange Act, making findings and imposing remedial sanctions. The order permanently bars Mayer from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. [SEC v.
