ENFORCEMENT PROCEEDINGS

PROCEEDING INSTITUTED AGAINST ROBERT BRENNAN

On September 1, 1995, the Commission issued an Amended Order Instituting Proceedings Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Robert E. Brennan which adds allegations by the Division of Enforcement regarding the judgment entered by the Honorable Richard Owen in SEC v. First Jersey Securities, Inc. and Robert E. Brennan, No. 85 Civ. 8585, RO, SDNY. In a separate order issued on August 31, 1995, the Commission accepted for review the Division of Enforcement's appeal from Chief Administrative Law Judge Brenda R. Murray's decision dismissing the proceeding against First Jersey Securities, Inc. on the ground that the original proceeding was not instituted within the period provided by Rule 15b6-1 following First Jersey's filing of a Form BDW seeking to withdraw from registration as a broker-dealer. COMMISSION BARS STEEN RONLOV

The Commission instituted a public administrative proceeding against Steen Ronlov (Ronlov) pursuant to Section 203(f) of the Investment Advisers Act. Simultaneous with the institution of the proceedings, Ronlov submitted an Offer of Settlement in which, while neither admitting nor denying the Commission's findings, he consented to the

entry of an Order barring him from association with any broker, dealer, investment company, investment adviser or municipal securities dealer. The Order was based on a permanent injunction against Ronlov entered in an action arising from the Commission's ongoing investigation concerning the activities of convicted felon and security violator, Steven D. Wymer (Wymer) and the investment advisers controlled by Wymer, Denman & Co. and Institutional Treasury Management, Inc. (collectively, ITM). The Commission's complaint alleges that Ronlov, while acting as an ITM salesman, solicited potential advisory clients knowing that Wymer would misappropriate their funds and thereafter concealed Wymer's misappropriation of five clients' investments by reporting fabricated profitable trades to the clients. Furthermore, Ronlov directly misappropriated \$250,000 from a prospective ITM client and also participated in Wymer's nominee option trading, profiting an additional \$1,373,973. In total, Ronlov received \$1,681,283 in ill-gotten gains. (Rel. 34-14629)

COMMISSION INSTITUTES PROCEEDINGS AGAINST DEMITRIOS JULIUS SHIVA

The Commission instituted proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Demitrios Julius Shiva (Shiva), formerly associated with a registered broker-dealer. On October 21, 1994, Shiva was permanently enjoined from further violations of the anti-fraud provisions. Later, on June 13, 1995, the Fourth Circuit Court of Appeals affirmed the District Court's decision. The Court found that Shiva had participated in a scheme to defraud by attempting to deposit certificates representing \$1.6 billion in counterfeit Japanese yen bonds. The Court found that Shiva misrepresented the authenticity, ownership and value of the certificates. (Rel. 34-36202)

FINAL JUDGMENTS ENTERED AGAINST ROBIN MCPHERSON AND GENE CARDENAZ, FORMER OWNERS AND PRINCIPALS OF CONTINENTAL WIRELESS CABLE TELEVISION, INC.

On August 9, the Honorable Edward J. Schwartz, United States District Court Judge for the Southern District of California, entered a Final Judgment of Permanent Injunction against Robin J. McPherson (McPherson) and Gene R. Cardenaz (Cardenaz), two of the owners and principals of Continental Wireless Cable Television, Inc. Pursuant to their consents, McPherson and Cardenaz were enjoined from violating Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. In addition, McPherson agreed to disgorge \$1,063,503.37 plus prejudgment interest thereon, and Cardenaz agreed to disgorge \$1,108,651.90 plus prejudgment interest thereon, provided, however, that payment of all but \$194,350.00 (McPherson) and \$30,760.00 (Cardenaz) was waived based upon their demonstrated inability to pay the remainder. Civil penalties were not imposed based upon McPherson's and Cardenaz' demonstrated inability to pay penalties.

The Commission's complaint, filed May 11, 1994, alleged that McPherson, Cardenaz, and Jay R. Bishop, through Continental, misappropriated and misused approximately 75% of \$39 million raised in the fraudulent offer and sale of interests in wireless cable television "general

partnerships." See LR-14118 and LR-14163. [SEC v. Continental Wireless Cable Television, Inc. et al., Civ. Action No. 94-0737S, BTM, S.D. Cal.] (LR-14630)

COMPLAINT FILED AGAINST DEFENDANTS ENGAGED IN SEAFOOD FINANCING PROGRAM

The Commission announced the filing of a complaint on September 6 in the U.S. District Court for the Central District of California, against Joy L. Bouwkamp (Bouwkamp) and Joe L. Hallock (Hallock) seeking injunctions against violations of the securities registration and antifraud provisions of the federal securities laws. The complaint also charges Thomas M. Grahovac (Grahovac) with antifraud violations. Additionally, Douglas Laughlin (Laughlin), Regency Investment Trust (Regency) and George Alama (Alama) are charged with violations of the securities registration and broker-dealer registration provisions. The complaint seeks an accounting and disgorgement against Bouwkamp, Hallock and Grahovac, and the imposition of civil penalties against Laughlin, Regency and Alama.

The complaint alleges that Bouwkamp and Hallock, principals of B. H. Rothchild & Gray (Canada) Lt'ee (B.H. Rothchild), raised approximately \$24 million from about 480 investors during 1990-1992 from the United States and Canada in connection with a purported seafood financing program, which was to involve B.H. Rothchild's subsidiary Ocean Best Seafood & Trading, Inc. However, the financing program did not exist. Investor funds were used to pay other investors and for unauthorized business and personal expenses. Laughlin, Regency and Alama acted as unregistered broker-dealers in offering and selling interests in the financing program. [SEC v. Joy L. Bouwkamp et al., Civil Action No. 95-5975, RAP, SHx, C.D. Cal.] (LR-14631)

INVESTMENT COMPANY ACT RELEASES

SECURITY LIFE OF DENVER INSURANCE COMPANY, ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting Security Life of Denver Insurance Company (Security Life), Security Life Separate Account L1 (Separate Account) and ING America Equities, Inc., formerly known as LSD Equities, Inc. from Sections 27(a)(3) of the Act and Rule 6e-3(T)(b)(13)(ii) thereunder. Applicants have been granted exemptive relief to issue certain variable life insurance contracts with a front-end sales load structure in which the percentage of sales charge deducted from any target premium payment could exceed that percentage deducted from any premium payment made in a prior year in excess of the target premium. (IC-21333 - September 6)

DEUTSCHE BANK AG

An order under Section 6(c) of the Investment Company Act has been issued on an application filed by Deutsche Bank AG. The order grants an exemption from Section 17(f) of the Act to permit United States

registered investment companies, other than investment companies registered under Section 7(d), for which Deutsche Bank serves as custodian or subcustodian, to maintain foreign securities and other assets in Malaysia with Deutsche Bank (Malaysia) Berhad, a subsidiary of Deutsche Bank. (IC-21334; ISR-849 - September 6)

LINDNER FUND, INC.

A notice has been issued giving interested persons until October 2 to request a hearing on an application filed by Lindner Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (IC-21335 - September 6)

LINDNER DIVIDEND FUND, INC.

A notice has been issued giving interested persons until October 2 to request a hearing on an application filed by Lindner Dividend Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (IC-21336 - September 6)

AUSA LIFE INSURANCE COMPANY, INC., ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act granting exemptions to AUSA Life Insurance Company, Inc. (AUSA Life), AUSA Series Annuity Account B (the Variable Account), and InterSecurities, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Variable Account and of any other separate account established in the future by AUSA Life, in connection with the issuance and sale of certain variable annuity contracts. (IC-21337 - September 7)

HOLDING COMPANY ACT RELEASES

CENTRAL OHIO COAL CO., ET AL.

An order has been issued authorizing a proposal by Central Ohio Coal Company, Southern Ohio Coal and Windsor Coal Company, all subsidiary companies of Ohio Power Company, an electric utility subsidiary company of American Electric Power Company, Inc., a registered holding company, to sell coal to nonassociate companies through December 31, 2000. (Rel. 35-26369)

SELF-REGULATORY ORGANIZATIONS

DELISTINGS GRANTED

An order has been issued granting the application of the Boston Stock Exchange to strike from listing and registration Transcor Waste Services, Inc., Common Stock, \$.001 Par Value. (Rel. 34-36195)

An order has been issued granting the application of the New York Stock Exchange to strike from listing and registration The Leslie Fay Companies, Common Stock, \$1.00 Par Value. (Rel. 34-36196)

PROPOSED RULE CHANGE

The Options Clearing Corporation filed a proposed rule change (SR-OCC-95-11) under Section 19(b) of the Securities Exchange Act. The proposed rule modifies OCC's Capital Computation Formula and Reporting Requirements Applicable to Canadian Clearing Members. Publication of the proposal is expected in the Federal Register during the week of September 11, 1995. (Rel. 34-36197)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-Phlx-95-16) filed by the Philadelphia Stock Exchange pursuant to Rule 19b-4 under the Securities Exchange Act of 1934 which increases the position and exercise limits for industry index options from 5,500, 7,500, or 10,500 contracts to 6,000, 9,000, or 12,000 contracts. Publication of the approval order is expected in the Federal Register during the week of September 11. (Rel. 34-36194)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change (SR-Phlx-95-56) filed by the Philadelphia Stock Exchange which allows the Phlx to list for trading cash-settled, European-style options of the Phlx Forest and Paper Products Sector Index has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the order is expected to appear in the Federal Register during the week of September 11, 1995. (Rel. 34-36193)

A proposed rule change filed by the Philadelphia Stock Exchange to amend the Phlx's Schedule of Fees and Charges (SR-Phlx-95-64) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of September 11. (Rel. 34-36198)
