## ENFORCEMENT PROCEEDINGS

---

**INITIAL DECISION SUSPENDS REGISTRATION OF BROKER/DEALER D.E. WINE FOR 30 DAYS, AS WELL AS SUSPENDS RANDAL MILLER, KENNETH KARPF, AND DUNCAN WINE FOR 30 DAYS FROM ASSOCIATION WITH ANY BROKER OR DEALER**

Administrative Law Judge Glenn R. Lawrence suspended the registration of D.E. Wine Investments, Inc. (registrant) as a broker and dealer with the Securities and Exchange Commission, for a period of 30 days. Registrant was ordered to pay a penalty of \$20,000 pursuant to § 21B of the Exchange Act and under § 8A of the Securities Act and § 21C of the Exchange Act to permanently cease and desist from committing or causing any violation of § 17(a) of the Securities Act and §§ 10(b) and 15(c) of the Exchange Act and Rules 10b-5 and 15c1-2 thereunder. Registrant was ordered to account and disgorge, jointly and severally with the other respondents in the proceeding, \$33,873.53 consisting of the excessive undisclosed markups and markdowns charged to customers in 89 transactions.

Judge Lawrence further ordered that W. Randal Miller, Kenneth B. Karpf, and Duncan E. Wine, who during the relevant time period were registered representatives and registered principals associated with registrant, each be suspended for a period of 30 days from association with any broker or dealer under §§ 15(b)(6) and 19(h) of the Exchange Act. They were each ordered to pay a penalty of \$5,000 pursuant to § 21B of the Exchange Act, and under § 8A of the Securities Act and § 21C of the Exchange Act to permanently cease and desist from committing or causing any violation or future violations of § 17(a) of the Securities Act and §§ 10(b) and 15(c) of the Exchange Act and Rules 10b-5 and 15c1-2 thereunder. They were also ordered under § 8A of the Securities Act and § 21C of the Exchange Act to account and disgorge, jointly and severally with the other respondents to this proceeding, \$33,873.53 consisting of the excessive undisclosed markups and markdowns charged to customers in the 89 transactions identified herein.

In evaluating the appropriate sanctions, Judge Lawrence gave consideration to the number and magnitude of the excessive undisclosed markups charged; respondents' refusal to acknowledge the illegality of the pricing policy; and revisions to registrant's pricing policy. In imposing penalties in the public interest, Judge Lawrence gave consideration to the following: the conduct involved reckless disregard of a regulatory requirement; the extent that respondents were unjustly enriched by the markup policy; the NASD finding of similar violations; and the need to deter others. **FINAL JUDGMENT OF PERMANENT INJUNCTION AND OTHER RELIEF ENTERED AGAINST MARK SHELBY, CHRISTOPHER COOPER, AND PHYSICIANS FINANCIAL, INC.**

The Commission announced that on October 3 the Honorable G. Ernest Tidwell, United States District Judge for the Northern District of Georgia, entered a permanent injunction enjoining Mark Shelby (Shelby), Christopher Cooper (Cooper), and Physicians Financial, Inc. (PFI), a Utah corporation, from violating Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder. Cooper was also enjoined from violating Section 15(a)(1) of the Exchange Act. The defendants consented to the relief without admitting or denying the allegations in a complaint filed by the Commission on April 20, 1994. Disgorgement was ordered but waived as to Shelby and Cooper, \$2,460,793.90, and PFI, \$34,116.91.

The Commission alleged that defendants offered and sold \$2.5 million in securities issued by Medical Financial Services, Inc. (MFS), and subsequently PFI, Idaho and Utah corporations, respectively, engaged in the business of factoring medical accounts receivable, by making misrepresentations and omitting to state material facts concerning MFS's financial condition and use of an independent, bonded escrow agent. MFS previously consented to a permanent injunction, appointment of a receiver, and payment of disgorgement and civil penalties.
