## INVESTMENT COMPANY ACT RELEASES

---

### MITCHELL HUTCHINS PORTFOLIOS, ET AL.

An order has been issued on an application filed by Mitchell Hutchins Portfolios, et al. under Section 17(d) of the Investment Company Act and Rule 17d-1 under the Act. The order permits certain registered open-end management investment companies to enter into a joint arrangement pursuant to a special servicing agreement. (Rel. IC-23252 - June 16)

### BOSTON 1784 FUNDS, ET AL.

An order has been issued on an application filed by Boston 1784 Funds and BankBoston, N.A. under Section 12(d)(1)(J) of the Investment Company Act exempting applicants from Sections 12(d)(1)(A) and (B) of the Act, under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act, and under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain joint transactions. The order permits certain registered open-end management investment companies to invest excess cash and cash collateral in affiliated money market funds. (Rel. IC-23253 - June 16)

### UBS INVESTOR PORTFOLIOS TRUST, ET AL.

An order has been issued on an application filed by UBS Investor Portfolios Trust, Union Bank of Switzerland (UBS), UBS Asset Management (New York) Inc., and UBS International Investment London Limited under Section 6(c) of the Investment Company Act granting relief from Section 15(a) of the Act. The order permits the implementation, without prior shareholder approval, of new investment advisory and sub-advisory agreements (New Advisory Agreements) in connection with the merger of UBS and Swiss Bank Corporation (Merger). The order covers a period of up to 150 days following the later of: (i) the date on which the Merger is consummated, or (ii) the date upon which the requested order is issued (but in no event later than December 31, 1998) (Interim Period). The order also permits, following shareholder approval, the payment of all fees earned under the New Advisory Agreements

during the Interim Period. (Rel. IC-23254 - June 16)

## SELF-REGULATORY ORGANIZATIONS

---

### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-CBOE-98-17) filed by the Chicago Board Options Exchange, and granted accelerated approval of Amendment No. 2 thereto, to list and trade warrants on a narrow-based index. Publication of the notice is expected in the Federal Register during the week of June 15. (Rel. 34-40085; International Series Rel. 1140)

The Commission approved a proposed rule change submitted by NASD Regulation (SR-NASD-98-23) to amend Rule 2860(b) of the National Association of Securities Dealers (NASD or Association) to: (1) increase the position limits on conventional equity options to three times the basic position limits for standardized equity options on the same security; (2) disaggregate conventional equity options from standardized equity options and FLEX Equity Options for position limit purposes; and (3) provide that the OTC Collar Aggregation Exemption shall be available with respect to an entire conventional equity options position, not just that portion of the position that is established pursuant to the NASD's Equity Option Hedge Exemption. The Commission approved a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-97-36) to revise the exchange's policy regarding the entry of market-on-close and limit-at-the-close orders and the publication of order imbalances. (Rel. 34-40094)

### PROPOSED RULE CHANGE

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-98-04) to add Addendum T to NSCC's Rules and Procedures regarding NSCC's obligation to continuously review participants to determine if they are required to reapply for membership due to a material change in conditions. Publication of the proposal is expected in the Federal Register during the week of June 15. (Rel. 34-40086)

### DELISTING GRANTED

An order has been issued granting the application of the American Stock Exchange to strike from listing and registration Millennia, Inc., Common Stock, \$0.0002 Par Value. (Rel. 34-40095)
