COMMISSION ANNOUNCEMENTS

SUSAN OCHS NAMED DIRECTOR OF THE OFFICE OF LEGISLATIVE AFFAIRS

SEC Chairman Arthur Levitt today named Susan M. Ochs as incoming Director of the Commission's Office of Legislative Affairs. Ms. Ochs, currently the Deputy Director of the Office of Legislative Affairs, will succeed Kaye F. Williams, who is departing the Commission in September.

Chairman Levitt said, "Susan Ochs has been an invaluable member of our legislative team. Since her arrival, she has demonstrated a remarkable facility with the nuanced and technically complex issues facing the Commission. Her unique background, a blend of Wall Street experience and government service, gives Susan a practical perspective on the work of the Commission and its effect on the private sector. I have relied on her insightful counsel and sound judgment during this busy legislative season, and I look forward to our continued work together."

As Director, Ms. Ochs will be the SEC's principal architect of legislative policy and will advise the Chairman and the Commission. She will serve as the chief liaison to Members of Congress and their staffs and will monitor legislation concerning the Commission. Ms. Ochs will also coordinate the preparation of congressional testimony for the Chairman, Commissioners, and senior SEC staff.

Ms. Ochs has served as Deputy Director of the Office of Legislative Affairs at the Commission since December 1997. Before joining the Commission, Ms. Ochs was an analyst in the Office of Legislative Affairs at the Treasury Department where she worked on banking, appropriations and international trade issues. Previously, she coordinated arbitrage and derivative trades and managed cash positions as a portfolio assistant at J.P. Morgan Investment Management, Inc. from 1993 until 1995.

Ms. Ochs graduated cum laude from Duke University with a B.A. in economics. (Press Rel. 98-78)

ENFORCEMENT PROCEEDINGS

CEASE-AND-DESIST ORDER ENTERED AGAINST JACQUELINE BADGER MARS

On August 25, the Commission issued an Order pursuant to Section 21C of the Securities Exchange Act of 1934 against Jacqueline Badger Mars (J.B. Mars), requiring her to cease and desist from committing or causing any violations of, or future violations of, Sections 13(d) and 16(a) of the Exchange Act and Rules 13d-1, 13d-2, 16a-2 and 16a-3 promulgated thereunder. J.B. Mars is and has been a beneficial owner of more than ten percent of the equity securities of AmerAlia, Inc. (AmerAlia). Since August 1987, the shares of AmerAlia has been quoted on the NASDAQ SmallCap Market.

J.B. Mars, without admitting or denying the allegations in the Commission's Order, consented to the entry of the Order finding that she: (1) failed to timely file for periods ranging from one week to more than two years and ten months seventeen amendments to Schedule 13D, reporting acquisition of the equity securities of AmerAlia and changes thereto, and (2) failed to timely file thirteen Forms 4 for periods ranging from three weeks to more than two years, reporting changes in her beneficial ownership of the equity securities of AmerAlia, and failed to timely file for six months, and one year and six months, two Forms 5. The value of J.B. Mars' stock transactions in late Form 4 filings for AmerAlia is approximately \$2.2 million. (Rel. 34-40362; File No. 3-9685)

INVESTMENT COMPANY ACT RELEASES

GREAT PLAINS FUNDS, ET AL.

An order has been issued on an application filed by Great Plains Funds and First Commerce Investors, Inc. under Section 12(d)(1)(J) of the Investment Company Act for an exemption from Section 12(d)(1) of the Act, and under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a) of the Act. The order permits applicants to implement a fund of funds arrangement. The fund of funds may invest in funds in the same group of investment companies and in other funds within the limits of Section 12(d)(1)(F) of the Act. The order also grants applicants an exemption from the sales load limitation in Section 12(d)(1)(F) of the Act. (Rel. IC-23398 - August 24)

UIH LATIN AMERICA, INC.

An order has been issued on an application filed by UIH Latin America, Inc. under Section 3(b)(2) of the Investment Company Act declaring applicant to be primarily engaged in a business other than that of investing, reinvesting, owning, holding or trading in

securities. (Rel. IC-23399 - August 25)

MEMBERS MUTUAL FUNDS AND CIMCO INC.

An order has been issued on an application filed by MEMBERS Mutual Funds and CIMCO Inc. under Section 6(c) of the Investment Company Act for an exemption from Section 15(a) of the Act and Rule 18f-2 under the Act. The order permits applicants to enter into and materially amend subadvisory contracts without obtaining shareholder approval. (Rel. IC-23400 - August 25)

HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

An order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, and CSW's wholly owned nonutility subsidiary, CSW Energy Services, Inc., to engage in the marketing, selling, leasing and renting of certain electric vehicles and related products. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the National Association of Securities Dealers relating to public and non-member access to Nasdaq's SelectNet and SOES systems through a member firm's own system (SR-NASD-98-54) has become effective upon filing under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected to be made in the Federal Register during the week of August 31. (Rel. 34-40354)

APPROVAL OF PROPOSED RULE CHANGES

The Commission has approved proposed rule changes filed by The Depository Trust Company and Participants Trust Company (File Nos. SR-DTC-98-12 and SR-PTC-98-02). The proposed rule changes relate to the arrangements for a merger between DTC and PTC. (Rel. 34-40357)
