RULES AND RELATED MATTERS

INTERMARKET TRADING SYSTEM

The Commission approved a proposed Intermarket Trading System (ITS) Plan (File 4-208) amendment (Thirteenth Amendment) submitted under Rule 11A by the ITS Operating Committee to eliminate the requirement that the Cincinnati Stock Exchange, Inc. submit proposed rule changes to its Rule 11.9 or the description of NSTS processing to other ITS Participants for review and comment prior to filing such changes with the Securities and Exchange Commission, and to make certain technical changes. Publication is expected in the Federal Register during the week of October 19. (Rel. 34-40553)

INVESTMENT COMPANY ACT RELEASES

FORMUS COMMUNICATIONS, INC., ET AL.

A notice has been issued giving interested persons until November 9, 1998, to request a hearing on an application filed by Formus Communications, Inc. and Formus International, Inc. for an order under Section 6(c) of the Investment Company Act to permit applicants and certain of their controlled companies to participate in certain foreign telecommunications ventures without being subject to the provisions of the Act. (Rel. IC-23486; International Series Rel. 1162 - October 14)

THE DREYFUS/LAUREL TAX-FREE MUNICIPAL FUNDS

A notice has been issued giving interested persons until November 9, 1998, to request a hearing on an application filed by The Dreyfus/Laurel Tax-Free Municipal Funds (Trust) for an order under Section 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order would permit a series of the Trust to acquire all of the assets and liabilities of two other series of the Trust. Because of certain affiliations, the applicant may not rely on Rule 17a-8 under the Act. (Rel. IC-23487 - October 15)

THE VICTORY PORTFOLIOS AND KEY ASSET MANAGEMENT, INC.

A notice has been issued giving interested persons until November 9, 1998, to request a hearing on an application filed by The Victory Portfolios and Key Asset Management, Inc. for an order pursuant to Section 12(d)(1)(J) of the Investment Company Act granting an exemption from Sections 12(d)(1)(A), (B) and (F) of the Act, and under Sections 6(c) and 17(b) of the Act granting an exemption from Section 17(a) of the Act. The order would permit applicants to implement a "fund of funds" arrangement. In addition to the fund of funds investing in other funds in the same group of investment companies, the order would permit the fund of funds to invest a portion of its assets in funds that are not part of the same group of investment companies in reliance on Section 12(d)(1)(F) of the Act. The order would also allow the funds of funds to offer its shares to the public with a sales load that exceeds the 1.5% limit of Section 12(d)(1)(F)(ii). (Rel. IC-23488 - October 15)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the New York Stock Exchange to increase the number of floor governors (SR-NYSE-98-31) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of October 12. (Rel. 34-40539)

A proposed rule change (SR-CHX-98-23) filed by the Chicago Stock Exchange relating to the submission of written statements by respondents in disciplinary investigations, or "Wells Submissions," has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of October 19. (Rel. 34-40550)

PROPOSED RULE CHANGES

The Chicago Stock Exchange filed a proposed rule change (SR-CHX-98-25) relating to the addition of an interpretation to the minimum variation rule. Publication of the proposal is expected in the Federal Register during the week of October 19. (Rel. 34-40545)

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-98-11) to modify NSCC's rules regarding its Mutual Fund Services transfer service. Publication of the proposal is expected in the Federal Register during the week of October 19. (Rel. 34-40549)

The Depository Trust Company filed a proposed rule change (SR-DTC-98-16) to modify its Initial Public Offering Tracking System with respect to reporting of resales of IPO shares by institutional

customers and of stock loans of IPO shares. Publication of the proposal is expected in the Federal Register during the week of October 19. (Rel. 34-40552)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

A proposed rule change (SR-PCX-98-50) filed by the Pacific Exchange to make the LMM Book Pilot Program permanent was approved under Section 19(b)(2) of the Securities Exchange Act of 1934. Publication of the order is expected in the Federal Register during the week of October 19. (Rel. 34-40548)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the Pacific Exchange (SR-PCX-98-36) to amend PCX Rules 15.2 and 15.3 regarding OptiMark. Publication of the order is expected in the Federal Register during the week of October 19. (Rel. 34-40551)

The Commission approved a proposed rule change submitted by the Philadelphia Stock Exchange (SR-Phlx-97-53) to establish an enhanced parity split pilot program for specialists in foreign currency options, effective until October 1, 1999. Publication of the order is expected in the Federal Register during the week of October 19. (Rel. 34-40557)
