## COMMISSION ANNOUNCEMENTS

### CHAIRMAN LEVITT SUPPORTS POB'S AUDIT EFFECTIVENESS PANEL

Chairman Arthur Levitt thanked the AICPA's Public Oversight Board for answering his call to create a special panel to study the effectiveness of audits. The panel will make a comprehensive review of the current methods used to audit financial statements and determine if the present model and recent changes serve the interest of investors. ## RULES AND RELATED MATTERS

---

### OTC DERIVATIVES DEALERS

The Commission adopted a new regulatory scheme that will provide U.S. securities firms with greater flexibility in structuring their OTC derivatives activities. Under the new regulations, a new class of dealers, called OTC derivatives dealers, may register with the Commission. Registration as an OTC derivatives dealer is available to entities that engage in dealer activities in eligible over-the-counter derivative instruments (both securities and non-securities OTC derivative products) and that meet certain financial responsibility and other requirements. Registration as an OTC derivatives dealer is optional and is an alternative to registration as a broker-dealer under the Commission's current rules.

OTC derivatives dealers will be subject to carefully tailored capital and other regulatory requirements appropriate to conducting an OTC derivatives business. OTC derivatives dealers will also be exempted from certain margin provisions contained in the Exchange Act provided they comply with the more flexible margin requirements customarily applied to banks. ## **WILLIAMSBURG INVESTMENT TRUST, ET AL.**

An order has been issued on an application filed by Williamsburg Investment Trust, et al. under Sections 6(c) and 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act. The order permits portfolios of Williamsburg Investment Trust (Trust) not advised by Davenport & Company LCC (Davenport) to engage in principal transactions with Davenport, which is an adviser to another portfolio of the Trust. ## **JOHN HANCOCK INSTITUTIONAL SERIES TRUST**

A notice has been issued giving interested persons until November 17, 1998 to request a hearing on an application filed by John Hancock Institutional Series Trust (Trust) for an order under Section 17(b) of the Investment Company Act for an exemption from Section 17(a) to permit an in-kind redemption of shares held by certain affiliated persons of the Trust. ## **SELF-REGULATORY ORGANIZATIONS**

### **PROPOSED RULE CHANGES**

The Depository Trust Company filed a proposed rule change (SR-DTC-98-13). The proposed rule change relates to establishing a practice of collecting the difference between a participant's required fund deposit and its actual fund deposit more frequently. Publication of the proposal is expected in the Federal Register during the week of October 26. (Rel. 34-40588)

The Philadelphia Stock Exchange filed a proposed rule change (SR-PHLX-98-37) to adopt Rule 220, which governs the procedures for stopping stock. Publication of the proposal is expected in the Federal Register during the week of October 26. (Rel. 34-40593)

### **IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES**

The Depository Trust Company filed a proposed rule change (SR-DTC-98-17). The proposed rule change, which became effective upon filing, relates to enhancements of its Memo Segregation procedures. Publication of the proposal is expected in the Federal Register during the week of October 26. (Rel. 34-40589)

A proposed rule change (SR-PCX-98-49) filed by the Pacific Exchange to amend the PCX's Specialist Post Fee Waiver Program, has become immediately effective. Publication of the notice is expected in the Federal Register during the week of October 26. (Rel. 34-40590)

A proposed rule change (SR-BSE-98-9) filed by the Boston Stock Exchange relating to its fee schedule has become effective immediately. Publication of the proposal is expected in the Federal Register during the week of October 26. (Rel. 34-40591)

A proposed rule change (SR-NASD-98-77) filed by the National Association of Securities Dealers revising Central Registration Depository (CRD) fees has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934.
