THE PUBLIC UTILITY HOLDING COMPANY ACT
OF 1935

On November 7, 1974, the Commission ordered a temporary suspension, until March 31, 1975, of the competitive bidding requirements of Rule 50 with respect to common stock offerings by registered holding companies (Rel. 35-18646, 5 SEC Docket 417). That order also directed a public investigatory hearing to begin at 10 a.m. Monday, January 6, 1975, at the Commission's headquarters, 500 North Capitol Street, Washington, D.C. 20549.

The hearing is scheduled to run from 10:00 a.m. to 12:00 noon and from 2:00 p.m. to 4:30 p.m. on January 6, 7, 8, and 9, 1975. On January 6, 7, and 8, 1975, the hearing will be held in room 776 at 500 North Capitol Street. On Thursday, January 9, 1975, the hearing will be held in the large, first floor hearing room at 1100 L St., N.W., Washington, D.C.

COMMISSION ANNOUNCEMENTS

RONALD W. DUNDON BARRED FROM ASSOCIATION WITH ANY BROKER-DEALER

Administrative Law Judge Ralph Hunter Tracy has filed an initial decision ordering that Ronald W. Dundon, formerly Division Manager of the Midwest and Central Southwest Division of Walston & Co., Inc. be barred from association with any broker-dealer with the provision that after one year he may apply to the Commission for permission to become associated with a broker-dealer in a non-supervisory capacity. The decision is subject to appeal to the Commission.

The Administrative Law Judge found that Dundon wilfully violated and wilfully aided and abetted violations of the registration and antifraud requirements of the Securities Act of 1933 and the antifraud provisions of the Securities Act and the Securities Exchange Act of 1934 in connection with a Walston underwriting. The Administrative Law Judge found that Dundon abused his position of authority at Walston by encouraging and rewarding an unlicensed trainee in the offer and sale of securities by means of untrue statements of material facts and omissions to state material facts necessary in order to make the statements made, in the light of the circumstances under which they were made, not misleading, thus participating in and aiding and abetting a fraudulent scheme to distribute securities.

WORKING CAPITAL OF NONFINANCIAL U.S. CORPORATIONS (SEPTEMBER 30, 1974)

According to estimates released by the SEC, the net working capital of nonfinancial U.S. corporations rose \$6.2 billion in the third quarter of 1974. This gain in working capital compares with \$4.2 billion in the previous quarter and \$4.2 billion a year earlier. A measure of corporate liquidity, the current ratio (the ratio of total current assets to total current liabilities), was 1.61 in the third quarter of 1974, little changed from 1.62 in the previous quarter as compared to 1.65 a year earlier. Net working capital which represents corporate investment in current assets in excess of current liabilities, totaled \$263.6 billion at the end of September 1974. TRADING SUSPENSIONS

TRADING SUSPENDED IN BURMAH OIL COMPANY

Over-the-counter trading has been suspended in the securities of Burmah Oil Company for a ten-day period beginning on January 3 and terminating at midnight (EST) January 12, 1975.

The suspension was initiated because of uncertainty concerning the financial condition of Burmah Oil. The Commission has been informed that the securities of Burmah Oil have been suspended from trading on the London Stock Exchange. (Rel. 34-11165)

ADDITIONAL ACTION ON FOUR TRADING SUSPENSIONS

The SEC has announced the suspension of exchange and over-the-counter trading in the securities of Equity Funding Corp., and over-the-counter trading in the securities of Zenith Development Corp., Industries International, Inc. and Westgate California Corp. for the further ten-day period January 7 - 16, inclusive.

COURT ENFORCEMENT ACTIONS

PINEHURST MORTGAGE AND LOAN CORPORATION,
OTHERS, PRELIMINARY INJUNCTION DENIED

The Atlanta Regional Office announced that on December 3 the Federal Court at Greensboro, North Carolina denied the Commission's motion for a preliminary injunction against Pinehurst Mortgage and Loan Corporation, Frederick N. Boswell, David Nichols and Merritt R. Clements, Jr., of Southern Pines, North Carolina, and Howard E. Herndon of Atlanta, Georgia, from alleged violations of the antifraud provisions of the securities laws in the offer and sale of investment notes of Pinehurst and its application for the appointment of a receiver for Pinehurst. The court also denied all motions filed by the defendants, including their motion to dismiss the complaint. A pre-trial conference has been scheduled for January 22, 1975. (SEC v. Pinehurst Mortgage and Loan Corporation, et al., M.D. N.C. - C-74-248R). (LR-6663)

COMPLAINT NAMES L.T.P. PROPERTIES,
INC., OTHERS

The Atlanta Regional Office announced the filing of a complaint on December 27 in the U.S. District Court for the Southern District of Florida seeking to enjoin L.T.P. Properties, Inc. (L.T.P.), S.E.I., Inc., Southeast Florida Corporation, Frank R. Carcaise, David R. Edstrom and Phillip M. Swan, from violations of the securities laws and the appointment of a receiver for L.T.P.

The complaint charges violations of the registration and antifraud provisions of the securities laws in the offer and sale of the promissory notes of L.T.P. The complaint in particular alleges that the defendants made false and misleading statements and omissions of material facts concerning: the financial condition of L.T.P.; the proceeds from L.T.P. notes that were to be utilized to develop The Swallows Golf and Country Club; L.T.P.'s ability to pay interest on monies invested; L.T.P.'s absence of income; diversion of proceeds from the sale of L.T.P. notes to the use of Frank R. Carcaise and a Pennsylvania corporation; the appraised value of land collateralizing L.T.P. notes; and L.T.P.'s inability to operate or meet its obligations without the sale of promissory notes. (SEC v. L.T.P. Properties, Inc., et al., S.D. Fla., Civil Action No. 74-1680-Civ.-J.E.). (LR-6664)

THE CONNECTICUT LIGHT AND POWER COMPANY

A notice has been issued giving interested persons until January 27 to request a hearing on a proposal of The Connecticut Light and Power Company, subsidiary of Northeast Utilities, to issue and sell up to \$85 million principal amount of first mortgage bonds. The net proceeds will be used to retire a portion of CL&P's short-term indebtedness. (Rel. 35-18755 - Jan. 3)

An order has been issued granting the application of The American Stock Exchange to strike from listing and registration the common stock of Storm Drilling and Marine, Inc.
