PROPOSAL TO AMEND COMMISSION RULES CONCERNING PUBLIC AVAILABILITY OF STAFF LETTERS OF COMMENT AND MOST CORRESPONDENCE WITH THE COMMISSION; PROCEDURES FOR REQUESTS FOR CONFIDENTIAL TREATMENT OF SENSITIVE INFORMATION REVEALED IN CORRESPONDENCE

LIBRARY.

In recognition of the fact that staff letters of comment in connection with registration statements or with other materials filed with the Commission and correspondence between members of the public and the Commission's staff do not necessarily contain sensitive information entitled to be withheld from public scrutiny consistent with the Freedom of Information Act, the Commission has proposed to amend its rules relating to public availability of such materials by repealing paragraph (1) of 17 CFR 200.80(c)(4).

In addition, the Commission has proposed to adopt a new rule 17 CFR 200.83 to implement procedures that will to the fullest extent permitted by law allow affected persons to request and obtain confidential treatment of information supplied to the Commission other than in formal filings. For further information, see Securities Act Release No. 33-5561, to be published in the SEC Docket, copies of which may also be obtained on request from the Commission's Public Reference Room. Interested persons are invited to submit their views on these proposals. To be considered, written statements should be submitted to the Secretary, Securities and Exchange Commission, Washington, D.C., on or before February 28, 1975. All such communication should refer to File No. S7-549, and will be available for public inspection. (Rel. 33-5561)

TRADING SUSPENSIONS

IBM, TELEX CORP. TRADING SUSPENDED

The SEC announced the temporary suspension of exchange and over-the-counter trading in all securities of International Business Machines Corp. (IBM), a New York corporation located in Armonk, New York, and Telex Corp., a Delaware corporation located in Tulsa, Oklahoma beginning on January 24 to allow time for investors and shareholders of the above companies to consider the judgment issued by the U. S. Court of Appeals for the Tenth Circuit in the matter of Telex Corp. and Telex Computer Products, Inc. v. International Business Machines Corp. The Commission has ordered the suspension of trading in order to allow time for the public to be fully informed regarding the decision. The suspension will terminate at 10:00 a.m. on January 28 or earlier if it appears to be in the public interest to do so. (Rel. 34-11208)

TRADING SUSPENDED IN BIO-MEDICAL SCIENCES, INC.

The SEC announced the suspension of over-the-counter trading in the securities of Bio-Medical Sciences, Inc. (Bio-Medical), a New Jersey corporation with its principal office located in Fairfield, New Jersey, for the ten-day period beginning at 10:00 a.m. (EST) on January 27 and terminating at midnight (EST) February 5, 1975.

On January 23, 1975, Bio-Medical issued a press release explaining a proposed transaction with Akzona, Inc. and stating that the completion of the transaction was dependent upon renegotiation of Bio-Medical notes with the note holders. The Commission suspended trading at the request of Bio-Medical because of uncertainties which exist until a settlement between Bio-Medical and its noteholders is reached. Trading in the securities of Bio-Medical will be suspended during the period of those negotiations. (Rel. 34-11209)

PENNSYLVANIA POWER COMPANY

A supplemental order has been issued approving the terms of the issue and sale of up to 80,000 shares of a new series of preferred stock by Pennsylvania Power Company, subsidiary of Ohio Edison Company. (Rel. 35-18784 - Jan. 23)

MIDDLE SOUTH UTILITIES

A supplemental order has been issued authorizing System Fuels, Inc., a non-utility subsidiary of Middle South Utilities, Inc., to increase by \$500,000 its previously authorized \$2,000,000 expenditures relating to a feasibility study in respect of a possible coal slurry pipeline extending from Wyoming to Arkansas. The increase is stated to cover certain over-runs from the originally estimated total cost of the study. (Rel. 35-18785 - Jan. 23)
