# TRADING SUSPENSIONS

### LIBRARY

TRADING SUSPENDED IN TWO COMPANIES

Over-the-counter trading has been suspended for a ten-day period beginning on March 20 and terminating at midnight (EDT) on March 29, 1975 of all securities of the following companies which have failed to file with the Commission at least the indicated reports: Southwestern Research Corp., a Delaware corporation located in Carefree, Arizona (10-K annual report for the fiscal year ended May 31, 1974; 10-Q quarterly reports for the fiscal quarters ended August 31, 1974 and November 30, 1974); NJB Prime Investors, a Massachusetts real estate investment trust, located in Clifton, New Jersey (10-K annual report for the fiscal year ended November 30, 1974).

The Commission initiated the suspensions because the companies failed to comply with the reporting provisions of the Exchange Act resulting in the lack of current and accurate information available to the public. (Rel. 34-11306)
