DECISIONS IN ADMINISTRATIVE PROCEEDINGS

C. I. OREN & CO., INC. REVOKED

The Commission has revoked the broker-dealer registration of C. I. Oren & Co., Inc., a New York City firm (the firm) being liquidated under the Securities Investor Protection Act. The sanction was based on findings that during September and October 1972, the firm aided and abetted violations of the antifraud provisions of the securities laws in that orders were placed to purchase the securities of Power Conversion, Inc. for the firm's account when it was known or there was reason to know that the firm would not consummate the transactions. The firm was also found to have violated the Securities Exchange Act's net capital, recordkeeping and reporting provisions.

Without admitting or denying the charges, the firm consented to the above findings and sanction. (Rel. 34-11422)

N. R. MAISON & CO., INC. REVOKED; NEAL R. MAISON SANCTIONED

> The Commission has revoked the broker-dealer registration of N. R. Maison & Co., Inc., of New York City. It also suspended Neal R. Maison, its president, from association with any broker, dealer, investment adviser or investment company for one year, and barred him from any such association in a supervisory capacity with the proviso that, at the end of two years, he may apply to become so associated.

The sanctions were based on findings that, during the period from April to December 1973, the firm and Maison bid for and purchased Abatronic, Inc. stock while participating in its distribution, and made misstatements concerning the number and price of Abatronix shares offered to the public, the existence and size of a bona fide independent market for the stock, the return of investors' funds unless a minimum amount of such stock was sold within a specified number of days, the identity of all participants in the Abatronix offering, and Maison Co.'s membership in good standing on the Boston Stock Exchange. It was also found that the firm and Maison failed to comply with the prospectus-delivery, recordkeeping, credit-extension and reporting requirements, and were permanently enjoined from violating those provisions and the antifraud provisions of the securities laws.

The Commission's action was based on an offer of settlement in which the firm and Maison, without admitting or denying the charges against them, consented to the above findings and the indicated sanctions. (Rel. 34-11426)

DENIS MCCAULEY, OTHERS BARRED

The Commission has barred Denis McCauley, Robert E. Abrams and Philip K. Schneiderman, all of Minneapolis, from association with any broker, dealer, investment adviser or investment company. McCauley was chairman of the board of Denis McCauley & Co., Inc., a broker-dealer whose registration was revoked in another earlier proceeding (see SEC News Digest, April 29, 1975), and Abrams and Schneiderman were the firm's president and vice president, respectively. The order provides that McCauley and Schneiderman, after three years, and Abrams, after one year, may apply to the Commission to become associated with a broker-dealer in a non-supervisory and non-proprietary capacity.

The sanctions were based on findings that during September-November 1972, respondents effected a series of transactions in the stock of Monarch General, Inc. to raise its price artificially; sold such securities at excessive and unreasonable prices; and required customers to purchase Monarch shares in the aftermarket or to purchase the stocks of Econetics, Inc. and Faraday Laboratories, Inc. in order to obtain Monarch shares at the offering price. It was further found that respondents made false and misleading statements concerning the distribution of and the existence of an independent market for Monarch stock, prospective increases in its price, and the demand for such stock. It was also found that respondents, while participating in a distribution of Monarch securities, represented that they were being offered "at the market" without reasonable grounds to believe that a market for them existed other than that in the control of respondents.

Without admitting or denying the charges, respondents consented to the above findings and sanctions. (Rel. 34-11427)

NASD ACTION AGAINST VAROSH, INC. AND BOTEO TACHKOV AFFIRMED

The Commission has affirmed sanctions imposed by the NASD on Varosh, Inc., a former New York City broker-dealer firm, and Boteo Tachkov, its president, now of Washington, D.C. The NASD censured the firm and Tachkov, and fined them \$1250.

The Commission found, as had the NASD, that, during the period April 1970 through May 1972, Varosh and Tachkov improperly extended credit to customers, and failed to arrange with customers for prompt delivery of securities which the firm was selling for them. (Rel. 34-11430)

COURT ENFORCEMENT ACTIONS

COMPLAINT NAMES BANK VOM LINTHGEBIET, OTHERS

The SEC announced the filing of a complaint in the U.S. District Court for the Southern District of Florida seeking permanent injunctions to enjoin Bank Vom Linthgebiet, Uznach, Switzerland, Eli Timoner, Miami, Florida, Robert M. Thompson, Jr., Largo, Florida, Donald R. Baker, Clearwater, Florida, Robert N. Bussey, Buenos Aires, Argentina, Ramon N. D'Onofrio, Pensacola, Florida, Alfred P. Herbert, Rapperswil, Switzerland and Markus O. Kaiser, Zurich, Switzerland from violations of the antifraud provisions of the securities laws in transactions in the securities of Investment Property Builders, Inc. (IPB), a Delaware corporation, headquartered in Miami, Florida, predecessor to Air Florida Systems, Inc.

The complaint alleges among other things that during 1971 the defendants engaged in a scheme to artificially manipulate and increase the market price of IPB stock. The complaint alleges that as a part of and in furtherance of the scheme, the defendants Timoner, Thompson, Baker, Bussey and D'Onofrio met in March 1971 and agreed to acquire a large block of IPB shares through the use of a secret Swiss bank account at Bank Vom Linthgebiet with the participation and aid of defendants Herbert and Kaiser. As a result of the defendants' activities, IPB shares increased from the equivalent of \$1.88 per share on April 6, 1971, to \$9.00 per share by October 12, 1971.

The Commission also announced the entry of orders of permanent injunction against defendants Eli Timoner and Robert M. Thompson, Jr., enjoining them from violations of of the antifraud provisions of the securities laws. The defendants consented to the entry of these orders without admitting or denying the allegations of the Commission's complaint. (SEC v. Bank Vom Linthgebiet, et al.). (LR-6902)

B.S.F. COMPANY

(TPC), a Japanese corporation and a Dupont affiliate, of an exclusive license, with the right to grant sublicenses, to certain Japanese patent rights, and to use related technical information. OHIO POWER COMPANY

An order has been issued authorizing Ohio Power Company (Ohio), subsidiary of American Electric Power Company, Inc., to issue and sell up to 400,000 shares of a new series of cumulative preferred stock through competitive bidding. Ohio will use the net proceeds for the payment of unsecured short-term indebtedness including the financing of part of its construction program for 1975. (Rel. 35-19000 - May 22)

THE CONNECTICUT LIGHT AND POWER COMPANY

An order has been issued authorizing The Connecticut Light and Power Company, The Hartford Electric Light Company, and Western Massachusetts Electric Company, subsidiaries of Northeast Utilities, to modify the earnings-coverage test relating to future issuances of additional bonds under their respective mortgage indentures. The authority sought would permit non-operating earnings from these companies' equity investments in four regional nuclear generating companies to be included in full for computation of earnings-coverage, while retaining the usual 10% limitation on inclusion of non-operating income derived from all other sources. Unilateral authorization by the Commission is permitted under the companies' mortgage indentures and would not require consent of the bondholders. (Rel. 35-19001 - May 22)

ALLEGHENY POWER SYSTEM

A notice has been issued giving interested persons until June 17 to request a hearing on a proposal by Allegheny Power System, Inc., a registered holding company that it act as surety for one of its electric utility subsidiary companies. (Rel. 35-19002 - May 22)

OHIO EDISON COMPANY
