DECISIONS IN ADMINISTRATIVE PROCEEDINGS

PAUL W. JONES & CO., AND R. A. KIMSEY & ASSOCIATES, INC. REVOKED; PRESIDENTS SANCTIONED

The broker-dealer registrations of the <u>Salt Lake City</u> firms of Paul W. Jones & Co. and R. A. Kimsey & Associates, Inc. have been revoked. Paul W. Jones, the Jones firm's president, has been suspended from association with a broker-dealer for 30 days and R. A. Kimsey, president of the Kimsey firm, has been censured.

The sanctions were based on findings that Jones & Kimsey violated the antifraud provisions of the Exchange Act in connection with the purchase and sale of the common stock of New Era Industries, Inc. Kimsey & Associates and Kimsey committed additional fraud in connection with the offer, sale and purchase of the common stock of Western Oil Development Company. Jones & Kimsey artificially influenced market prices and created the false and misleading appearance of active markets. Moreover, they effected transactions involving no change in the beneficial interests therein. Finally, they entered purchase and sale orders with the knowledge that substantially offsetting sale and purchase orders had been or were to be entered.

Without admitting or denying the charges against them, Jones & Kimsey consented to the above findings and sanctions. (Rel. 34-11471)

TRANSFER OF REGULATIONS A AND F FILING REQUIREMENTS TO THE LOS ANGELES REGIONAL OFFICE

The Los Angeles Regional Office announced the transfer to the Los Angeles Regional Office from the San Francisco Branch Office of filing and review responsibilities for all filings submitted to the Commission under Regulation A (Rules 251 to 263) and F (Rules 651 to 656) under the Securities Act of 1933. The Los Angeles Region includes the States of Arizona, California, Hawaii, and Nevada and the Territory of Guam.

On or after July 1, 1975 materials will be accepted for filing only in Los Angeles. Accordingly, all new filings, as well as material relating to filings previously submitted to the San Francisco office, shall be directed to the Commission's office in Los Angeles. Where the documents relate to filings prior to July 1, 1975, the material will be forwarded to San Francisco for review, consideration and appropriate disposition.
