NOTICE OF FILING OF PROPOSED RULE CHANGES PURSUANT TO SECTION 19(b)(1)

The Boston Stock Exchange, PBW Stock Exchange, Inc. and the Midwest Stock Exchange Inc. (the Exchanges) filed, pursuant to Section 19(b) of the Securities Exchange Act of 1934, as amended, new rules (the Rules) of the TAD Depository Corporation (TAD) relating to the implementation of a depository interface between TAD and National Clearing Corporation (NCC). NCC also submitted procedures, reports and forms (the Procedures) relating to the implementation of a depository interface between TAD and NCC pursuant to Section 19(b)(1) of the Act. The Exchanges and NCC requested the Commission to issue an order, pursuant to Section 19(b)(3)(B) of the Act, determining that, pursuant to paragraphs (g) of Rules 8c-1 and 15c2-1 under the Act, the Rules and Procedures were adequate for the protection of investors.

The Commission ordered (1), pursuant to Section 19(b)(3)(B) of the Act, that the Rules and Procedures relating to the implementation of the depository interface between NCC and TAD, filed with the Commission on July 22, 1975, be put into effect summarily, effective July 31, 1975, until such time as the Commission, pursuant to Section 19(b)(2) of the Act, either approves the Rules and Procedures or institutes proceedings to determine whether such Rules and Procedures should be disapproved and (2) that the Rules and Procedures be deemed adequate for the protection of investors. ### **TRADING SUSPENSIONS**

OTA INDUSTRIES, ALLIED GENERAL & MAIN LINE LEETS TRADING SUSPENDED

The SEC has announced the temporary suspension of trading for a ten-day period beginning on August 13 and terminating at midnight (EDT) on August 22, 1975 of all securities of the following companies which have failed to file 10K annual reports for the year ended December 31, 1974 with the Commission: Iota Industries, Inc., a Delaware corporation located in New York City, listed on the PBW Stock Exchange, and traded over-the-counter; Allied General, Inc., located in Princeton, Florida, and traded over-the-counter; Main Line Fleets, Inc., located in Wayne, Pennsylvania, and traded over-the-counter. DDITIONAL ACTION ON THREE TRADING SUSPENSIONS

The SEC has announced the suspension of (a) exchange and over-the-counter trading in the securities of Equity Funding Corp., and (b) over-the-counter trading in the securities of Industries International Inc. and Westgate California Corp. for the further ten-day period August 15 - 24, inclusive.

## OURT ENFORCEMENT ACTIONS

ATIONAL FARMERS ORGANIZATION, INC., OTHERS RDER DENIED

The Chicago Regional Office announced that on July 25 U.S. District Judge W. C. Stuart of the Federal Court for the Southern District of Iowa denied the Commission's motion for the appointment of a receiver for National Farmers Organization, Inc. and NFO Member's Custodial Account, an express trust. The order was conditioned on the defendant entities taking certain steps to prepare, and file with the Court, commencing October 10, 1975, financial statements prepared by independent accountants.

The order specifically reserves the Commission's right to renew its request for a receiver should National Farmers Organization, Inc. fail to comply with the Court's order, or should that organization's financial circumstances decline drastically in the future. (SEC v. National Farmers Organization, Inc., et al., S.D. Iowa C. A. Nos. 74-162-1 and 74-241-1). (LR-7041)

### INVESTMENT COMPANY ACT RELEASES

#### JOHN HANCOCK INVESTORS

A notice has been issued giving interested persons until September 8 to request a hearing on an application of John Hancock Investors, Inc., a registered closed-end investment company, and John Hancock Mutual Life Insurance Company, for an order permitting applicants to engage in certain transactions involving investments in notes of the Gates Rubber Company. #### VANTAGE TEN-NINETY FUND

An order has been issued declaring that Vantage Ten-Ninety Fund, Inc., has ceased to be an investment company as defined in the Act. (Rel. IC-8887 - Aug. 13)

EQUITABLE VARIABLE LIFE INSURANCE COMPANY, SEPARATE ACCOUNT I

A notice has been issued giving interested persons until September 12 to request a hearing on an application of Equitable Variable Life Insurance Company (EVLICO), Separate Account I of EVLICO and The Equitable Life Assurance Society of the United States for an order exempting them from certain provisions of the Act.

EVLICO and Separate Account I have filed registration statements under the Securities Act of 1933 for the offering of two types of variable life insurance (VLI) contracts. Separate Account I has registered under the Act as an open-end management investment company. Applicants have requested exemptions from the Act to allow them to offer, sell and administer these VLI contracts in accordance with the requirements of State insurance laws and their established administrative systems and procedures. The exemptions requested are concerned primarily with management accountability, sales loads and pricing for purchase and redemption. (Rel. IC-8888 - Aug. 13)

### HOLDING COMPANY ACT RELEASES

#### GEORGIA POWER COMPANY

An order has been issued authorizing Georgia Power Company, subsidiary of The Southern Company, to enter into agreements with five Georgia counties whereby the counties will construct for Georgia's pollution control facilities financed by the counties' sale of up to \$31,700,000 of pollution control revenue bonds. Georgia will acquire the facilities upon their completion pursuant to installment sale agreements. (Rel. 35-19124 - Aug. 12)
