ADOPTION OF AMENDMENT TO RULE 6c-2(T) AND
PROPOSAL TO ADOPT AN AMENDED VERSION OF RULE 6c-2

LIBRARY

The Commission today announced the adoption of an amendment to temporary Rule 6c-2(T) under the Investment Company Act of 1940 (Act) and a proposal to adopt an amended version of proposed Rule 6c-2 under the Act. Rule 6c-2(T) was initially adopted and Rule 6c-2 initially proposed on February 26, 1974 (Rel. IC-8251) to provide substantial exemptive relief for corporations organized pursuant to the Alaska Native Claims Settlement Act of 1971 ("ANCSA Corporations" and "Settlement Act," respectively).

The amendment to Rule 6c-2(T) is designed to make clear that the relief afforded by the temporary rule is retroactive to December 18, 1971, the date of enactment of the Settlement Act and that registration pursuant to Section 8(a) of the Act is necessary to qualify for the exemptive relief afforded by the rule. Rule 6c-2(T) will remain in effect as now amended until such time as the Commission adopts the proposed permanent rule or rescinds Rule 6c-2(T).

The Commission's proposal to adopt Rule 6c-2 will invite additional public comment on the proposed rule, which is substantially different from the original version. Proposed Rule 6c-2 would continue the principle of Rule 6c-2(T) of subjecting ANCSA Corporations registering under Section 8(a) (ANCSA Registrants) only to the basic provisions of the Act. Thus, ANCSA Registrants would be exempt from Sections 8(b), 11, 12, 13, 14, 15(b), 15(d), 16, 18, 19, 20(b), 20(c), 20(d), 21(a), 22, 23, 24, 26, 27, 28, 29, 30(b)(1), 30(c), 30(f), 32(a)(2), 32(a)(3), 32(a)(4), 35(a), 35(b), and 35(c) of the Act, and rules and regulations adopted by the Commission under such sections. In addition, the Rule would provide substantial partial relief from Section 17's restrictions on affiliated transactions, and from the proxy solicitation, periodic reporting and financial recordkeeping requirements of the Act. ANCSA Registrants would be subject to all other provisions of the Act, including in particular, the provisions dealing with composition of boards of directors, approval of investment advisory agreements, appointment of independent public accountants. The new structure of the rule would also embrace a number of provisions of the Act of a definitional or administrative nature, or which pertain to the Commission's authority to enforce the Act.

The Commission today announced the adoption of amended Rule 17a-3(a) (12) (A) (8) under the Securities Exchange Act of 1934 (17 CFR 240.17a-3(a) (12) (i) (h)). Rule 17a-3(a) (12) (A) requires every member of a national securities exchange who transacts a business in securities directly with others than members of a national securities exchange, and every broker or dealer who transacts a business in securities through the medium of any such member, and every registered broker or dealer to obtain from each associated person a questionnaire or application for employment containing, among other things, a record of any arrests, indictments, or convictions for any felony or misdemeanor, except minor traffic offenses to which the associated person has been subject. The Commission has amended Rule 17a-3(a) (12) (A) (8) to limit the reference to arrests or indictments to crimes which are related to the safe operation of the securities industry. The amendment was proposed in Rel. 34-11402, May 7, 1975 (Rel. 34-11615)

ANNOUNCE MOST MEMBERS OF NATIONAL MARKET ADVISORY BOARD

The Commission has announced the names of those persons who have agreed to serve as members of the National Market Advisory Board. The Commission was directed to establish the Advisory Board by the provisions of Section 11A(d) of the Securities Exchange Act of 1934 as amended by the Securities Acts Amendments of 1975.

The Advisory Board will submit its views to the Commission to assist it in its regulatory oversight of the nation's securities markets generally and with the implementation of a national central market system, consistent with the public interest and the protection of investors. In addition, the Advisory Board is directed to report to the Congress, on or before December 31, 1976, as to whether a new self-regulatory organization, a National Market Regulatory Board, to administer the national market system, should be established.

COMMISSION ACTION ON FREEDOM OF INFORMATION ACT REQUEST

The Commission denied the request of David Cohen for access to certain investgatory records relating to Gulf Oil Corporation and Minnesota Mining and Manufacturing Company. In both cases the Commission has brought an injunctive action and obtained an injunction prohibiting further violations of the securities laws by the companies In addition, the companies have consented to complete an internal investigation by a specified date and to file a report which shall be made publicly available. In both cases, disclosure of the requested information at this time would interfere with pering or prospective law enforcement proceedings, and the requested records are therefore exempted from such disclosure by the seventh exemption. COURT ENFORCEMENT ACTIONS

DEFENDANTS ENJOINED RE POLARIS MINING

The Denver Regional Office on August 19 announced that the Honorable Fred M. Winner, Judge, U. S. District Court at Denver, entered orders on August 11, 1975 to which the defendants consented, preliminarily enjoining Leo G. Bateman, H. DeWorth Williams, and George D. Fehr pending the final determination of this action from purchasing, selling, or in any way dealing in Polaris Mining Company securities.

The complaint alleged, among other things, the defendants and others violated the registration provisions of the federal securities laws in connection with the offer and sale of the common stock of Polaris Mining Company. (SEC v. Polaris Mining Company, Inc., et al., D. Colo Action No. 75-W-695) (LR-7050)

IRVIN D. KAPLAN ENJOINED

The Fort Worth Regional Office announced that on August 19 the federal district court in Houston, Tex. entered an order of permanent injunction against Irvin D. Kaplan, Houston, enjoining him from further violations of the antifraud provisions of the Securities Exchange Act. The complaint was filed contemporaneously with the order to which the defendant had consented without admitting or denying the allegation.

The Commission's complaint alleges that the defendant engaged in a securities trading and check manipulation scheme wherein he defrauded several brokerage firms through the purchase and sale of corporate, government, and municipal bonds. VALHI SUSPENSION TERMINATED

The Commission announced on August 22 that the temporary suspension of over-the-counter trading in the securities of Valhi, Inc., located in Houston, Tex., will terminate at midnight (EDT) on August 24, 1975. The Commission initiated the trading suspension on August 15, 1975 concurrently with the filing of an injunctive action in the Southern District of Texas (Houston Division) against U.S. District Court for the Southern District of Texas (Houston Division) against D. Doyle Mize, Valhi, Southdown, Inc. Farnham Corporation, Leland McCarthy and Richard McCarthy, charging violations of the anti-fraud provisions and tender offer Provisions of the securities acts.
