## **COURT ENFORCEMENT ACTIONS**

#### JAMES SNYDER ENJOINED

The Commission announced that on November 7 a permanent injunction by default was issued against James Snyder of Las Vegas, Nevada, by the U.S. District Judge Alfonso Zirpoli of the U.S. District Court for the Northern District of California enjoining Mr. Snyder from violations of the antifraud and proxy provisions of the securities laws. (SEC v. Howard R. Hughes, et al., N.D. Cal., Civil Action No. C-75-0589-AJZ). (LR-7156)

#### CLIFFORD W. RUSSELL INDICTED

The Fort Worth Regional Office announced that on November 6 a Federal Grand Jury at Fort Worth, Texas returned a five-count indictment against Clifford W. Russell, Dallas, charging him with mail fraud, sale of unregistered securities, and fraud in the offer and sale of securities. The indictment charges that beginning in 1973 Russell sold fractional undivided working interests in Mississippi and Oklahoma oil and gas leases issued by Sawood Petroleum Corporation (formerly Petroleum Production Corporation), Dallas, in violation of the securities laws and the mail fraud statute. (SEC v. Clifford W. Russell, N.D. Tex.). (LR-7157)

# CAPITAL SYNDICATIONS INCORPORATED AND CAPITAL SYNDICATIONS COMPANY ENJOINED

The Fort Worth Regional Office announced that on November 5 Federal District Judge Eldon B. Mahon at Fort Worth, entered an order of permanent injunction by consent against Capital Syndications Incorporated and Capital Syndications Company, both of Fort Worth. Previously, on October 8 Judge Mahon entered orders of permanent injunction by consent against Wayne R. Morgan, Fort Worth, and Jesse D. Sanders, Dallas, Texas.

The above orders were issued as a result of the Commission's complaint filed July 22, 1974 which had alleged that Capital Syndications Incorporated, Capital Syndications Company, Morgan and Sanders violated the antifraud provisions of the securities laws in the sale of limited partnership interests in real estate syndications. (SEC v. Capital Syndications Incorporated, et al., N.D. Tex.). (LR-7158)

#### LONDON INVESTORS, LTD., OTHERS ENJOINED

The Fort Worth Regional Office announced that on November 4 Federal District Judge Stephen S. Chandler at Oklahoma City, Oklahoma issued an order of permanent injunction by summary judgment against London Investors, Ltd., Grand Cayman Islands, British West Indies, Jerome Leslie Goldberg, Tarzana, California and Betty Jo Smay, Oklahoma City, permanently enjoining them from violations of the registration and antifraud provisions of the securities laws.

At the same time, Judge Chandler entered orders of permanent injunction by default against Barclays Investment Corporation, Carson City, Nevada, Commtrade of Nebraska, Inc., Omaha, Nebraska, and Financial General Corporation, Oklahoma City, permanently enjoining them from violations of the registration, antifraud and broker-dealer registration provisions of the securities laws.

The above orders were issued as a result of the Commission's complaint which had alleged that the defendants engaged in the offer and sale of investment contracts in the form of purported options on commodity future contracts traded on the American Commodity Exchange, Oklahoma City, Oklahoma, without registering such securities with Commission. Additionally, the complaint alleged that Barclays Investment Corporation, Commtrade of Nebraska, Inc. and Financial General Corporation effected transactions in securities without registering as broker-dealers with the Commission. (SEC v. American Commodity Exchange, et al.). (LR-7159)

The Denver Regional Office announced that Judge Fred M. Winner of the U.S. District Court for the District of Colorado signed final judgments of permanent injunction against Polaris Mining Company and Russell H. Twiford, Jr., also known as Inter-World Minerals. The judgments permanently enjoin the defendants from violating the registration and antifraud provisions of the securities laws in connection with the offer for sale, sale or purchase of Polaris Mining Company common stock and fractional undivided interest in mineral rights by Twiford, Polaris and others. (SEC v. Polaris Mining Company, et al., U.S.D.C. Colo., 75-W695). (LR-7160)
