### RUSSIAN TELECOMMUNICATIONS DEVELOPMENT CORPORATION

An order has been issued under Sections 3(b)(2) and 45(a) of the Investment Company Act on an application filed by Russian Telecommunications Development Corporation declaring that it is primarily engaged in a business other than that of investing, reinvesting, owning, holding or trading in securities and granting confidential treatment with respect to certain asset valuation information. ### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the Philadelphia Stock Exchange and Amendment No. 1 thereto relating to the Exchange's options maintenance standards (SR-Phlx-2001-96) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of November 26. (Rel. 34-45086)

A proposed rule change filed by the International Securities Exchange relating to fees for providing "Bisync Controllers" to members (SR-ISE-2001-30) has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of November 26. (Rel. 34-45089)

A proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-2001-99) to conform Phlx Rule 2001(b)(2)(viii) to the Seventeenth Amendment of the Intermarket Trading System Plan relating to 30-second commitment expiration has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of November 26. (Rel. 34-45093)

### **ACCELERATED APPROVAL OF PROPOSED RULE CHANGE**

The Commission noticed and granted accelerated approval to a proposed rule change (SR-Phlx-2001-100) and Amendment Nos. 1 and 2 thereto submitted by the Philadelphia Stock Exchange, under Rule 19b-4 of the Securities Exchange Act of 1934, to extend a pilot program to disengage its automatic execution system (AUTO-X) for a period of thirty seconds after the number of contracts automatically executed in a given option meets the AUTO-X minimum guarantee for that option. Publication of the proposal is expected in the Federal Register during the week of November 26. (Rel. 34-45090)
