ENFORCEMENT PROCEEDINGS

COMMISSION GRANTS EAJA AWARD TO RUSSO SECURITIES

The Commission has awarded Russo Securities, Inc. (RSI), a Staten Island, New York brokerage firm, the sum of \$32,781.90 on the firm's claim under the Equal Access to Justice Act (EAJA). The Commission had earlier dismissed charges that RSI aided and abetted and was a cause of a fraudulent scheme by the Cooper Companies, Inc. In the subsequent EAJA proceeding, the Commission affirmed a law judge's conclusion that the record failed to establish that the Commission's action against RSI had been "substantially justified." The Commission's award included \$26,431.50 as reimbursement for RSI's legal fees, and \$6,350.40 for other litigation expenses incurred by RSI. (Rel. 34-42115; File No. 3-9484)

CIVIL CONTEMPT SOUGHT AGAINST ITALIAN ENTITY PROMOTING PYRAMID SCHEME OVER THE INTERNET

The Commission announced that on or about November 5 it filed an application seeking an order of civil contempt against Future Strategies Srl a/k/a Future Strategies International (Future

Strategies), an Italian entity headquartered in Carpi, Modena, Italy. The Commission's application seeks an order to show cause why Future Strategies should not be held in civil contempt for failing to comply with the Court's oral order converting the temporary restraining order to a preliminary injunction, and the Court's subsequent written order of preliminary injunction entered on June 16, 1999 enjoining Future Strategies from violations of the registration and anti-fraud provisions of the federal securities laws. Future Strategies consented to the entry of the preliminary injunction and other relief without admitting the allegations in the Commission's complaint.

The Commission's complaint alleges that Future Strategies is engaged in an ongoing, worldwide pyramid scheme, known as "Pentagono," promoted over the Internet. Such conduct violates the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 as well as the registration provisions of the Securities Act of 1933. The Commission's complaint alleges that, from at least May 1998, Future Strategies solicited United States residents to purchase Pentagono "Certificates," now called "Card Purchase Orders" or "CPOs," which Future Strategies prepared and issued. Thousands of United States participants have invested in this scheme. The complaint alleges that Future Strategies, as part of its solicitation, claims that an investor can earn up to \$116,400 from an investment of approximately \$120 through Pentagono. [SEC v. INVESTMENT COMPANY ACT RELEASES

J.P. MORGAN & CO. INCORPORATED

A notice has been issued giving interested persons until November 30 to request a hearing on an application filed by J.P. Morgan & Co. Incorporated (J.P. Morgan) for an order under Section 6(c) of the Investment Company Act to amend an existing order to permit additional entities to rely on the existing order, which exempts certain entities that finance the operations of J.P.
