ADMINISTRATIVE PROCEEDINGS

MICHAEL SUTTON WOLFE CITED

Pursuant to an Offer of Settlement by Michael Sutton Wolfe of Vallejo, California, a former registered representative of Birr Wilson & Co., the Commission has made findings and has entered an Order imposing remedial sanctions. The Order bars Wolfe from association with any broker or dealer, investment company, investment adviser, or municipal securities dealer.

The Commission's Order was based on findings that Wolfe wilfully violated the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934. Wolfe consented to the above findings and sanctions without admitting or denying the allegations in the Commission's Order Instituting Proceedings. (Rel. 34-17025)

INVESTMENT COMPANY ACT RELEASES

ZENITH GROWTH FUND, INC.

A notice has been issued giving interested persons until September 8 to request a hearing on a proposal by the Commission to declare by order on its own motion, pur-suant to Section 8(f) of the Investment Company Act of 1940, that Zenith Growth Fund, Inc., registered under the Act as an open-end, diversified, management invest-ment company, has ceased to be an investment company as defined in the Act. TRINWALL CASH RESERVE, INC.

INTERCAPITAL INCOME SECURITIES INC.

An notice has been issued giving interested persons until September 2 to request a hearing on an application filed by InterCapital Income Securities Inc., a registered, closed-end, diversified, investment company, InterCapital Liquid Asset Fund, Inc., a registered, open-end, diversified investment company (collectively, the InterCapital Funds) and Dean Witter Reynolds InterCapital Inc., adviser to the InterCapital Funds, for an order, pursuant to Section 10(e) (3) of the Investment Company Act of 1940, declaring that, for purposes of the requirements of Section 15(f)(1) of the Act, the period for filling a currently existing vacancy on each of the InterCapital Funds' boards of directors be expanded to 150 days. HOLDING COMPANY ACT RELEASES

INDIANA & MICHIGAN ELECTRIC COMPANY

An order has been issued authorizing Indiana & Michigan Electric Company, subsidiary of American Electric Power Company, Inc., to transfer its interests in certain coal mines, reserves and related assets having a cost of approximately \$190 million to its coal mining subsidiary, Blackhawk Coal Company. The order reserves jurisdiction with respect to proposed spending of up to \$13 million between January 1, 1981, and June 30, 1981, on mine improvements if a contemplated sale of such assets to non-affiliated parties is not consummated before December 31, 1980. NEW ENGLAND ENERGY INCORPORATED

An order has been issued authorizing New England Energy Incorporated, subsidiary of New England Electric System, to increase its budget for oil and gas exploration and development activities from \$30 million to \$60 million for the period January 1, 1980 through December 31, 1980. THE COLUMBIA GAS SYSTEM, INC.

A supplemental order has been issued authorizing proposals of The Columbia Gas System, Inc., a registered holding company, and some of its subsidiaries, whereby the holding company will make short-term advances to one of its subsidiaries and certain subsidiaries will issue and sell, and the holding company will acquire, installment notes. The proceeds of these transactions will be used by the subsidiaries in connection with their construction and gas supply programs. NOTICE OF PROPOSED RULE CHANGE

The Municipal Securities Rulemaking Board has filed a proposed rule change under Rule 19b-4 (SR-MSRB-80-7) to extend from September 24, 1980 to December 1, 1980, the effective date of certain amendments to MSRB rule G-15 relating to customer confirmations and to MSRB rule G-12 applicable to inter-dealer confirmations.
