PROPOSED REVISION OF REGULATION S-K AND GUIDES FOR THE PREPARATION AND FILING OF REGISTRATION STATEMENTS AND REPORTS

The Commission has approved the issuance of a release requesting comment upon proposed revision of Regulation S-K and the Guides for the Preparation and Filing of Registration Statements and Reports (the Guides). The proposals would (1) categorize by subject matter Regulation S-K, the repository of standard instruction for disclosure under the Securities Act of 1933 and the Securities Exchange Act of 1934; and (2) expand that Regulation by adding uniform disclosure requirements with respect to the distribution of securities. Registration statement forms would also be revised to incorporate by reference such uniform disclosure requirements. The proposals would also (1) eliminate the Guides, with the exception of the Guides for disclosure by registrants in a particular industry; and (2) incorporate certain of the requirements thereof into Regulation S-K, Regulation C (the rules governing the registration of securities under the Securities Act), and the General Rules and Regulations under the Securities Act and the Exchange Act. These proposals would eliminate out-moded and duplicative requirements, would enhance the integration of disclosure systems by consolidating and organizing disclosure provisions in Regulation S-K, and would consolidate procedural provisions in general rules and regulations.

SEPARATE REPORTS OF OTHER ACCOUNTANTS; AMENDMENTS TO PROXY RULES AND REGULATION S-X

The Commission has authorized the publication of a release requesting comments on proposed rule amendments which would eliminate requirements for inclusion of separate reports of other accountants in annual reports to security holders when part of an examination of financial statements is made by an independent accountant other than the principal accountant of the registrant or when prior period financial statements are examined by a predecessor accountant. Also, amendments to Schedule 14A are proposed which would clarify when financial statements may be incorporated by reference into proxy or information statements from the annual report to security holders and under what circumstances financial statements in proxy or information statements may be omitted. The Commission has provided for the application of the proposed rule amendments prior to effectiveness.

CIVIL PROCEEDINGS

OKC CORP. ENJOINED

The Fort Worth Regional Office announced that on December 16 Judge Robert M. Hill of the U.S. District Court for the Northern District of Texas, Dallas Division, entered an Order permamently enjoining OKC Corp., Dallas, Texas, from further violations of the periodic reporting and proxy provisions of the securities laws.

The complaint, filed on September 15, had alleged that since at least 1973, Cloyce K. Box, OKC's chief executive officer, pursuant to secret and undisclosed partnerships and business arrangements, caused OKC to purchase and sell substantial amounts of petroleum products through certain brokers who were his friends and business associates. Without admitting or denying any of the allegations in the complaint, OKC consented to the entry of the Order which, in addition to permanently enjoining it from further violations of the securities laws, provides that OKC shall continue to be subject to the terms of an Order entered by Judge Hill on November 25, requiring OKC to designate a special corporate committee to review each proposal for the sale, liquidation or other transfer of assets of OKC to assure compliance with the terms of the Plan of Liquidation and Dissolution of OKC as set forth in proxy solicitations to stockholders, and to assure that each sale, liquidation or transfer of assets is made without undisclosed conflicts of interest.

The Order does not include Cloyce K. Box of Dallas, Texas, who remains as a defendant in the case and is subject to the Order of Preliminary Injunction entered by Judge Hill on November 25. (SEC v. Cloyce K. Box and OKC Corp., N.D. Tex., Dallas Division, CA 3-80-1217D). (LR-9262)

RONALD E. SPIEGEL ENJOINED

The Chicago Regional Office announced that on December 5 the Honorable John Powers Crowley entered a Final Judgment and Order of Permanent Injunction against Ronald E. Spiegel. Spiegel consented to the injunction without admitting or denying the allegations in the Commission's complaint. The injunction arose from Spiegel's involvement in a \$25 million inventory and profit inflation scheme while employed with Cenco, Inc., a Chicago based corporation. Spiegel served as vice-president of Cenco, and president of Cenco Medical Health, a Cenco subsidiary.

In a parallel criminal action brought in the U.S. District Court for Northern Illinois, Spiegel was convicted of securities and mail fraud charges. He was sentenced to 30 months imprisonment, fined \$50,000, and placed on probation. Spiegel has appealed his conviction.

Entry of this order concludes over four years of Commission litigation against the 17 individuals and two corporation alleged to have committed the Cenco fraud. (SEC v. Cenco Incorporated, et al., N.D. Ill., Civil Action Nol 76 C 3258). (LR-9263)

INVESTMENT COMPANY ACT RELEASES

INSURED MUNICIPALS - INCOME TRUST

A notice has been issued giving interested persons until January 19, 1981, to request a hearing on an application filed by Insured Municipals-Income Trust, Investors' Corporate-Income Trust, Investors' Governmental Securities-Income Trust, Investors' Quality Tax-Exempt Trust, New York Insured Municipal Bond Trust (New York Trust), Pennsylvania Insured Municipal Bond Trust (Insured Trust), and Investors' Municipal Pennsylvania Unit Trust (IMPUT) (collectively called the Funds), registered under the Investment Company Act of 1940 as unit investment trusts, their sponsor, Van Kampen Filkin & Merritt, Inc., and Dain Bosworth, Incorporated, a co-sponsor of the Corporate Trust, for an order amending an earlier order of the Commission dated October 9, 1979 (Rel. IC-10895), to extend to certificateholders of Series 1 and subsequent series of IMPUT, the Insured Trust and the New York Trust the exchange privilege allowed by the earlier order, and to increase the sales charge imposed on all exchange transactions from \$15 per unit to \$25 per unit. The earlier order exempted from the provisions of Section 22(d) of the Act, pursuant to Section 6(c) of the Act, the offer and sale of Fund units pursuant to an exchange option involving the exchange of units of any series of a

Fund for units of any other series or several series of the same Fund, and permitted, pursuant to Section 11 of the Act, the exchange transactions to be effected on a basis other than the Funds' respective net asset values per unit at the time of the exchange. (Rel. IC-11514 - Dec. 24)

A notice has also been issued giving interested persons until January 19, 1981, to request a hearing on an application filed by the Funds, for an order amending an earlier order of the Commission dated August 12, 1980 (Rel. IC-11300), which earlier order amended other orders of the Commission which exempted an exchange offer by the unit investment trusts from the provisions of Section 22(d) of the Act pursuant to Section 6(c) of the Act, and permitted that exchange offer to be effected on a basis other than the trusts' net asset value per unit at the time of the exchange pursuant to Section 11 of the Act. The instant amendment proposes to extend the exchange offer to certificate holders of Series 1 and subsequent series of New York Insured Municipal Bond Trust, and to increase the sales charge imposed on all such exchange transactions from \$15 per unit to \$25 per unit.
