### INVESTMENT COMPANY ACT RELEASES

U.S. SECURITIES  
EXCHANGE COMMISSION

---

#### THE ARGENTINA GROWTH FUND, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that The Argentina Growth Fund, Inc. has ceased to be an investment company. (Rel. IC-18881 - August 5)

#### SELIGMAN CAPITAL FUND, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting Seligman Capital Fund, Inc., et al. from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The exemptions apply to the extent necessary to permit them to impose a contingent deferred sales charge (CDSC) on certain redemptions of shares and to waive the CDSC under certain circumstances. ### HOLDING COMPANY ACT RELEASES

---

#### CENTRAL AND SOUTH WEST CORP., ET AL.

An order has been issued concerning a proposal by Central and South West Corporation, a registered holding company, and three of its nonutility subsidiaries, CSW Energy, Inc. (Energy), CSW Development-I, Inc. (Energy Sub), ARK/CSW Development Partnership (Joint Venture), Polk Power GP, Inc. and Polk Power Partners, L.P. (Partnership). The order authorizes CSW, Energy, Energy Sub and the Joint Venture to make additional capital contributions in the amount of \$4.5 million to the Partnership, so that total equity contributions by Energy Sub would be \$13.5 million. The Partnership is also authorized by the order to increase the amount to be borrowed from third party lenders for use in constructing and developing the Project from approximately \$120 million to \$135 million at terms of up to 20 years. In addition, the order authorizes the Partnership to enter into a construction agreement with Energy or Energy Sub for the purpose of developing and constructing the Project (Construction Agreement). Further, CSW is authorized by the order to provide support agreements and/or letters of credit in connection with Energy Sub's equity obligations to the Partnership and Energy's obligations under the Construction Agreement. ## LISTING, DELISTING AND UNLISTED TRADING ACTIONS

---

### DELISTING GRANTED

An order has been issued granting the application of the American Stock Exchange to strike from listing and registration Fairfield Communities, Inc., 15 1/8% Subordinated Debentures, due February 15, 1997. (Rel. 34-31004)

### WITHDRAWAL GRANTED

An order has been issued granting the application of Craftmade International Inc. to withdraw from listing and registration its Common Stock, \$.01 Par Value, on the Boston Stock Exchange. (Rel. 34-31005)

### UNLISTED TRADING PRIVILEGES SOUGHT

A notice has been issued giving interested persons until August 25 to comment on the application of the Midwest Stock Exchange for unlisted trading privileges in 8 issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. ## SELF-REGULATORY ORGANIZATIONS

---

### PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-92-12) that would prohibit members from effecting short sales at or below the bid, for themselves or their customers, when the current "inside" or best bid is below the previous bid. The proposed amendment contains an exemption for transactions by "qualified" NASDAQ market makers. As amended, the proposal defines a "qualified" market maker for a one-year period as a market maker that has been registered and entering quotations in individual securities in the NASDAQ system on an uninterrupted basis for the preceding twenty business days. After the first year, the proposal would determine "qualified" market maker status based on four criteria related to the liquidity that a market maker provides in each security in question. Publication of the proposal is expected in the Federal Register during the week of August 10, 1992. (Rel. 34-31003)

## ACQUISITION OF SECURITIES

---

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
