CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST WILLIAM FRITZ, GORDON WHITTEN AND MARTIN PERRY

The Commission announced the filing of a complaint in the U.S. District Court for the District of Nebraska seeking injunctive and other relief against William J. Fritz (Fritz), Gordon Whitten (Whitten) and Martin D. Perry (Perry) alleging that they committed violations of Sections 5 and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder in connection with the fraudulent offer and sale of unregistered securities beginning in mid-1990. The defendants told investors that they would be eligible for "debt restructuring" if they invested \$5,000 or \$25,000 to become "charter members" of a program called the PM Co-op Trust. The defendants told investors that when they raised \$250,000, PM Co-op Trust would enter into an arrangement with a "Class A" bank on an Indian reservation in Oklahoma. The investor's mortgages could then be paid off for considerably less money than if they had not invested in the program. The defendants also promised that the investors' initial investment would be returned in 12 months. The complaint further alleges that at least 70 people, primarily Nebraska residents, invested a total of at least \$350,000 in the scheme. The defendants neither attempted nor intended to provide investors with any of the promised benefits, or to return their investments. Instead, the defendants simply deposited the proceeds into bank accounts under their control and converted the proceeds to their own use. [SEC v. William F. ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
