COMMISSION ANNOUNCEMENTS

FAF AND SEC REACH AGREEMENT ON CHANGES IN COMPOSITION OF ACCOUNTING FOUNDATION: APPOINTING THREE NEW TRUSTEES TO SERVE

The Financial Accounting Foundation (FAF) and the Commission today announced that they have reached an agreement for a change in the composition of the Foundation's Board. Specifically, the FAF will add two new At-Large positions, fill two existing At-Large vacancies and reduce the number of members appointed by sponsoring organizations by two. Three individuals have been asked and have agreed to serve as At-Large members of the FAF Board: John Biggs, Chairman and CEO of TIAA-CREF, Manuel Johnson, former Vice Chairman of the Federal Reserve, and David Ruder, former Chairman of the SEC. In addition, the FAF will extend an invitation to Charles Bowsher, Comptroller General of the United States, following the completion of his government service later this year. The FAF selected the new At-Large Trustees in consultation with the SEC. (Press Rel. 96-87)

RULES AND RELATED MATTERS

COMMISSION PROPOSES RULE CHANGES TO THE BENEFICIAL OWNERSHIP REPORTING REQUIREMENTS

The Commission has issued a release proposing amendments to the rules relating to the reporting of beneficial ownership in publicly-held companies. The proposals would make Schedule 13G available, in lieu of Schedule 13D, to all investors beneficially owning less than 20 percent of the outstanding class of securities that have not acquired or held the securities for the purpose of and do not have the effect of changing or influencing the control of the issuer of the securities. ENFORCEMENT PROCEEDINGS

CEASE AND DESIST ORDER ENTERED AGAINST NEIL COLVIN

On July 8, the Commission issued an Order pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) against Neil J. Colvin (Colvin), requiring him to cease and desist from committing or causing any violations or future violations of Sections 13(g) and 16(a) of the Exchange Act and Rules 13d-1, 13d-2, 16a-2, 16a-3, and former Rule 16a-1 thereunder. Colvin is a former officer and director of Phoenix Technologies Ltd. (Phoenix) and beneficially owned more than five percent of the common stock of Phoenix. Colvin, without admitting or denying the allegations in the Commission's Order, consented to its entry. The Order finds that Colvin failed for two months to file a Schedule 13G reporting his beneficial ownership of more than five percent of the equity securities of Phoenix, and failed for periods ranging from more than one month to more than seven years and one month to file eight amendments to his Schedule 13G reporting changes in his beneficial ownership of Phoenix Technologies' equity securities. The Order finds that Colvin was late in filing his Form 3 for Phoenix with the Commission, and has filed late for periods ranging from one week to more than two years and four months, nineteen Forms 4 reporting changes in his beneficial ownership of Phoenix common stock. The combined value of Colvin's stock transactions in late Form 4 filings for Phoenix is approximately \$4.3 million. (Rel. 34-37408)

INVESTMENT COMPANY ACT RELEASES

INSTITUTIONAL SERIES TRUST

A notice has been issued giving interested persons until July 31 to request a hearing on an application filed by Institutional Series Trust for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-22052 - July 5)

SAMUEL EVANS WYLY, ET AL.

A notice has been issued giving interested persons until July 30 to request a hearing on an application filed by Samuel Evans Wyly (Wyly) and Maverick Capital, Ltd. (Maverick) for temporary and permanent orders under Section 9(c) of the Investment Company Act. The orders would exempt Wyly and Maverick from the disqualification provisions of Section 9(a) of the Act with respect to a securities-related injunction entered against Wyly. (Rel. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-96-10) relating to modifications to the processing schedule for deposits and withdrawals of government securities eligible for settlement through the Federal Reserve Book-Entry System. Publication is expected in the Federal Register during the week of July 8. (Rel. 34-37394)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by The Options Clearing Corporation (SR-OCC-96-01) that amends the choice of law provisions and other provisions in OCC's by-laws and rules in connection with Illinois' adoption of the 1994 amendments to Articles 8 and 9 of the Uniform Commercial Code. PROPOSED RULE CHANGE

The Participants Trust Company filed a proposed rule change (SR-PTC-96-03) that will amend PTC's rules and will establish initial procedures to permit the intraday return of prefunding payments to participants. Publication of the proposal is expected in the Federal Register during the week of July 8. (Rel. 34-37402)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission approved on an accelerated basis a proposal (SR-NYSE-96-12) by the New York Stock Exchange to amend Paragraph 703.21 of the NYSE Listed Company Manual to provide alternate criteria for the listing and trading of hybrid debt securities whose value is linked to the performance of a non-U.S. company which is traded in the U.S. market as sponsored American Depository Shares, ordinary shares or otherwise. Publication of the approval order is expected in the Federal Register during the week of July 8. (Rel. 34-37405; IS-1002)

The Commission approved a proposed rule change filed by the National Association of Securities Dealers (SR-NASD-96-19) that amends the Uniform Application for Securities Industry Registration or Transfer, Form U-4, and the Uniform Termination Notice for Securities Industry Registration, Form U-5. The revised forms define how information will be collected and stored in the revised Central Registration Depository (CRD). (Rel. 34-37407)
