RULES AND RELATED MATTERS

DESIGNATION OF SMALL ENTITY COMPLIANCE GUIDES

The Commission has designated several of its publications that assist small entities in complying with Commission rules as small business compliance guides, as required by the Small Business Regulatory Enforcement Fairness Act of 1996, Pub. L. No. 104-121, 110 Stat. 857 (1996). The Commission has also determined to include in the Code of Federal Regulations the list of small business compliance guides and information concerning how members of the public may obtain them. The Commission designated the following publications as compliance guides:

PROPOSED CHANGES IN DEFINITIONS OF SMALL ENTITIES UNDER THE REGULATORY FLEXIBILITY ACT

The Commission is publishing for comment proposed amendments to the definitions of "small business" and "small organization" that are used in connection with Commission rulemaking under the Investment Company Act of 1940, the Investment Advisers Act of 1940, the Securities Exchange Act of 1934, and the Securities Act of 1933 regarding regulatory requirements applicable to investment companies, investment advisers, exchanges, securities information processors, transfer agents and issuers, and broker-dealers. These definitions are used specifically for purposes of the Regulatory Flexibility Act, which requires the Commission to consider the impact of its regulations on small entities. ENFORCEMENT PROCEEDINGS

CECIL SUTER BARRED FROM ASSOCIATION WITH REGULATED ENTITIES

The Commission today announced the institution of administrative proceedings against Cecil H. Suter (Suter). The Commission charged Suter with selling securities in the Israeli company I.I.S. Intelligent Information Systems Ltd. (IIS) on the basis of inside information he received while a director of IIS and with failing to disclose the sale to the Commission. Simultaneously with the institution of administrative proceedings, and without admitting or denying the findings contained therein except as to the entry of a permanent injunction against him by a Federal District Court, Suter consented to the entry of a Commission Order (Order). The Order bars Suter from association with any broker, dealer, investment company, investment adviser or municipal securities dealer.

The Commission's Order finds that the United States District Court for the Northern District of Illinois permanently enjoined Suter from further violations of the antifraud and insider trading reporting provisions of the federal securities laws (Section 17(a) of the Securities Act of 1933, Sections 10(b) and 16(a) of the Securities Exchange Act of 1934 and Rules 10b-5 and 16a-2 and 16a-3 thereunder). The Commission's Order finds that Suter avoided a loss of \$79,875.00 by selling 9,000 shares of IIS stock after learning inside information regarding IIS' low fourth quarter 1993 earnings. The Order further finds that by Friday, February 25, 1994, Suter knew of IIS' low quarterly earnings; that Suter nevertheless entered limit orders on that day to sell 9,000 shares of IIS stock at \$18.75 per share; that on Monday, February 28, 1994, while Suter was in Israel to attend an IIS Board of Directors meeting regarding IIS' fourth quarter 1993 earnings, he changed the price specification on his limit orders to \$18.50 per share; and that Suter's IIS sell orders were executed at \$18.50 per share on Tuesday, March 1, 1994, the day of the Board meeting. The Order also finds that Suter did not disclose to the Commission his sale of the IIS stock.

When IIS publicly announced its low fourth quarterly earnings on March 7, 1994, its stock dropped substantially and closed at \$9 5/8. (Rel. IA-1610)

EUGENE VALENTINE PERMANENTLY ENJOINED AND ORDERED TO PAY A \$50,000 CIVIL PENALTY

The Commission announced that Eugene R. Valentine (Valentine) has been permanently enjoined from knowingly falsifying any book, record or account required by the Commission and from making any materially false or misleading statements to an accountant in connection with the audit or examination of the issuer's financial statements, or preparation or filing of any document or report required by the Commission. Valentine also was required to pay a \$50,000 civil penalty. Valentine consented to the sanctions arising out of his conduct as former president, chief executive officer and chairman of the board of Valley Systems, Inc. (Valley), an industrial cleaning company.

The Commission filed its complaint against Valentine and others on September 14, 1995. The complaint alleged that Valley's understatement of expenses and overstatement of revenue resulted in Valley's filing three materially false quarterly reports. The complaint alleged that Valentine ordered that Valley record fictitious revenue, provided several false explanations for amounts of costs capitalized and understated workers' compensation insurance expenses.

Valentine consented to the injunction and civil penalty without admitting or denying the allegations in the complaint. [SEC v. Nicholas J. Pace and Eugene R. Valentine, USDC, ND of Ohio, Civil Action No. 5:95CV1999, Dowd] (LR-15226; AAE Rel. 873)
