ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST JOSEPH H. GASPERINI

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Joseph H. Gasperini, formerly a registered representative of a registered broker-dealer. Simultaneously, the Commission accepted Gasperini's offer of settlement, wherein he consented to the Order, without admitting or denying the allegations therein.

The Order finds that Gasperini wilfully violated the antifraud provisions of the Securities and Exchange Acts and Rule 10b-5. The Order alleges that from at least January 1982 through April 1983 Gasperini excessively traded options in clients' accounts, initiated unauthorized options transactions in accounts, misrepresented or failed to disclose the risks inherent in his options strategies, and traded options for clients who were unsuitable for options trading.

The Commission suspended Gasperini for 12 months from association with any broker-dealer, investment adviser, investment company or municipal securities dealer; barred Gasperini from association with any such entity in a supervisory capacity or from having any proprietary interest in any such entity; and imposed certain limitations on him should he become reassociated following his suspension, including a prohibition from entering any order for customers relating to the purchase or sale of any option. CIVIL PROCEEDINGS

FINAL JUDGMENT ENTERED AGAINST JOSE L. GOMEZ

The Atlanta Regional and Miami Branch Offices announced that on April 15 the U.S. District Court for the Southern District of Florida entered a Final Judgment of Permanent Injunction and Other Relief against Jose L. Gomez. Gomez consented to the Final Judgment without admitting or denying the complaint's allegations.

The March 20 complaint alleged that Gomez, an Alexander Grant & Company partner, caused Grant to issue unqualified auditor's reports on ESM's financial statements when Grant and Gomez were not "independent" by virtue of payments of at least \$125,000 to Gomez by certain principals of ESM.

Gomez was permanently enjoined from further violations of the antifraud provisions of the securities laws, including: certifying financial statements as an independent auditor when not independent of the audit client; and allowing dissemination to the public of such financial statements without disclosure of the lack of independence of the auditor. Gomez is also enjoined from providing services as an independent certified public accountant to, among others, issuers of securities and securities broker-dealers. Gomez must also disgorge to the ESM receiver an amount of money to be determined at a later hearing. (SEC v. Jose L. Gomez, USDC SDPL, Fort Lauderdale Division, Civil Action No. 85-6227-CIV-GONZALEZ). (LR-10747)

HOLDING COMPANY ACT RELEASES

MIDDLE SOUTH UTILITIES, INC.

A supplemental order has been issued authorizing Middle South Utilities, Inc., a registered holding company, to increase the amount of previously authorized stock that can be issued through a continuous offering shelf registration program (rather than on a delayed basis), in accordance with Rule 415 under the Securities Act of 1933, from four million shares to not more than ten million shares. (Rel. 35-23683 - May 8)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved proposed rule changes filed by: The Midwest Clearing Corporation (SR-MCC-85-2) requiring mandatory input of accrued interest on trade input forms for its Municipal Bond Comparison System. (Rel. 34-22018); and The National Securities Clearing Corporation (SR-NSCC-85-2) to delineate the current practice that NSCC follows regarding requests for the release of data within its possession and control. (Rel. 34-22024)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

Rule changes have become effective under Sections 19(b)(3)(A), 19(b)(2), and 19(b)(1), respectively, by: The Options Clearing Corporation (SR-OCC-85-5) to amend its Rule 602(a) to reduce the minimum margin requirement for Treasury securities and foreign currency options. (Rel. 34-22019); and The Boston Stock Exchange Clearing Corporation (SR-BSECC-84-2) revising its by-laws relating to the selection and composition of its Board of Directors; the selection and duties of its Audit Committee; and the establishment of its clearing fund. (Rel. 34-22020); and (SR-BSECC-84-1) revising its rules to reflect the current relationship between, and respective duties of, BSECC and its members and to reflect recent changes in BSECC's operations and BSECC's relationship with the National Securities Clearing Corporation and the Depository Trust Company. (Rel. 34-22021)
