### CIVIL ACTION AGAINST GORDON GOLDMAN

On January 28, the Commission filed a civil action in the United States District Court for the District of Columbia against Gordon K. Goldman, a certified public accountant, seeking a permanent injunction and civil monetary penalties for securities law violations allegedly committed in connection with his audit of College Bound, Inc.'s financial statements for the fiscal year ending August 31, 1991. Goldman allegedly audited those financial statements, which were contained in College Bound's Fiscal Year 1991 Annual Report on Form 10-K filed with the Commission, and signed an auditors report falsely certifying that they were prepared in accordance with generally accepted accounting principles (GAAP) and that he had audited them in accordance with generally accepted auditing standards (GAAS). The complaint alleges that those misrepresentations, made knowingly or recklessly, constituted violation of Section 17(a) of the Securities Act of 1933 (Securities Act) and Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder. It further asserts that by his conduct, Goldman aided and abetted violations of Exchange Act Section 13(a) and Rules 12b-20 and 13a-1 promulgated thereunder committed by College Bound. [SEC v. ## ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
