COURT ENFORCEMENT ACTIONS

KENNETH R. LARSEN ENJOINED

The Denver Regional Office announced that the Honorable Earl E. O'Connor, U.S. District Judge for the District of Kansas, on September 26 signed a final judgment of permanent injunction against Kenneth R. Larsen of Holt, Missouri, enjoining him, in substance, from violating the registration and antifraud provisions of the securities laws in the offer and sale of securities issued or offered by Royal American Chinchilla, Inc. or any other security of any issuer. This defendant was the final one to consent to the entry of the final order of permanent injunction without admitting or denying the allegations of the complaint filed against him and others on July 5, all of the other defendants having already consented to similar permanent injunctions. (SEC v. Royal American Chinchilla, Inc., et al., U.S.D.C. D. Kansas, Civil Action No. 77-2176). (LR-8153)

MAX L. MCCALL AND RALPH F. STRAND ENTER GUILTY PLEAS

The Denver Regional Office announced that on September 19 Max L. McCall of Fayetteville, North Carolina and Ralph Frederick Strand of Fayetteville, North Carolina, both entered a guilty plea to an information charging each of them with one count of fraud in the sale of securities of Cochise College Park, Inc. Honorable Walter E. Craig set October 17 as the sentencing date for each defendant. (U.S. v. Richard P. Curran, et al., U.S.D.C. Ariz., CR-76-323). (LR-8154)

GREATEASTERN FUND OF BOSTON
