ADMINISTRATIVE PROCEEDINGS

MEYER BERG BARRED

Pursuant to an Offer of Settlement submitted in these proceedings, the Commission has entered an order barring Meyer Berg of Coral Springs, Florida from association with any broker or dealer. The order barring Meyer Berg provides that after one year, Berg may apply to the Commission to become reassociated with a broker or dealer if he demonstrates to the Commission's satisfaction that his reassociation will not be adverse to the public interest and that he will be employed in a nonsupervisory capacity under appropriate supervision.

The sanction was based upon findings that Berg violated Section 17(a) of the Securities Act of 1933 and Section 9(a)(2), 10(b) and 13(d) and Rules 10b-5 and 13d-1 thereunder as well as aiding and abetting violations of Section 17(a)(1) of the Exchange Act and Rule 17a-3 thereunder. Berg consented to the findings without admitting or denying the allegations of the Order for Proceedings. (Rel. 34-17996)

The priority reproduction cost is 35¢ per page plus postage and applicable sales taxes (\$10.00 minimum order). Priority service orders will be shipped by 4:00 PM of the working day following the day of your telephoned request for materials already in the contractor's master files. Cost estimates are given on request.
