CIVIL PROCEEDINGS

FINAL JUDGMENTS ENTERED AGAINST LOUIS FISHER AND CYMATICOLOR CORPORATION

The Commission entered Final Judgments of Permanent Injunction on October 3 against Louis Fisher, of London, England, and Cymaticolor Corporation, of Edison, New Jersey (Fisher's Judgment was entered by default). The Judgments, issued by U.S. District Judge David N. Edelstein in New York, permanently enjoin the defendants from violating the registration and antifraud provisions, and Cymaticolor from violating the bookkeeping provisions, of the securities laws.

The June 27 complaint alleges that: Fisher and Cymaticolor, in concert with others, manipulated the initial public offering of Cymaticolor common stock and the subsequent over-the-counter trading of those shares; and Cymaticolor failed to maintain adequate financial controls. Cymaticolor consented to the Injunction without admitting or denying the Commission's allegations. (SEC v. Cymaticolor Corporation, et al., USDC SDNY, 84 Civ. 4508, DNE). (LR-10553)

JUDGMENTS OF PERMANENT INJUNCTION ENTERED AGAINST THOMAS DI SPIGNO, OTHERS

The Commission today announced that U.S. District Judge Charles S. Haight, Jr., Southern District of New York, entered Judgments of Permanent Injunction against Thomas Di Spigno, Anthony Brunetti, Leonard DiRusso and Christopher Moffatt, enjoining them from further violations of the antifraud and tender offer provisions of the securities laws. This action arises from allegations made by the Commission that they had engaged in insider trading based on material non-public information misappropriated from Sullivan & Cromwell. (SEC v. Dominick Musella, et al., USDC SDNY, 83 Civ. 342, CSH). (LR-10554)

CONTINENTAL ASSURANCE COMPANY CNA VARIABLE ACCOUNT
