U.S. SECURITIES AND
EXCHANGE COMMISSION

ADMINISTRATIVE PROCEEDINGS

STEVEN L. KOMM CENSURED

The Commission instituted proceedings under Rule 2(e) of its Rules of Practice against Steven Komm, a certified public accountant and former chief financial officer of Universal Money Centers, Inc. (UMCI), for violating and aiding and abetting violations of the antifraud, reporting, and books and records provisions of the securities laws. The Order, to which Komm consented, permanently denies him the privilege of practicing before the Commission and finds that he contributed to UMCI's inaccurately reporting, in its Forms 10-K and 10-Q filed in 1983 and 1984, three transactions purportedly involving the sale of 40 automated teller machines (ATM). The Order finds that UMCI should not have accounted for these transactions as sales because they were, in essence, financing transactions since the earnings process had not been completed and the risks of ownership had not transferred to the investors. Instead, the Order maintains that UMCI should have continued to carry the ATM's as assets, should have reflected a liability after its receipt of the investor monies, and finds that Komm signed these filings which materially overstated revenues and income and materially understated liabilities; did not cause UMCI's books and records to accurately reflect these transactions; and violated the antifraud provisions by allowing the release of numerous false press releases. INVESTMENT COMPANY ACT RELEASES

AMERICAN CHARTER FUNDING CORPORATION

A notice has been issued giving interested persons until March 4 to request a hearing on an application filed by American Charter Funding Corporation, formerly American Charter Financial Corporation (American Charter), a limited purpose finance subsidiary of American Charter Federal Savings and Loan Association, a federally chartered mutual savings and loan association, for an order conditionally exempting American Charter and one or more trusts (Issuer Trusts) formed by American Charter from all provisions of the Investment Company Act in connection with the issuance by American Charter and the Issuer Trusts of mortgage-backed securities and the sale of beneficial interests in American Charter and the Issuer Trusts. MACKAY-SHIELDS MAINSTAY TAX FREE BOND FUND

An order has been issued declaring that MacKay Shields Mainstay Tax Free Bond Fund has ceased to be an investment company. (Rel. IC-16264 - Feb. 11)

PILGRIM VARIABLE ANNUITY SEPARATE ACCOUNT

An order has been issued granting the First Capital Life Insurance Company, Pilgrim Variable Annuity Separate Account of First Capital Life Insurance Company, and Pilgrim Distributors Corporation exemptions from Sections 26(a)(2) and 27(c)(2) of the Investment Company Act to permit the deduction of a mortality and expense risk charge from the Accounts in connection with the issuance of certain individual variable annuity contracts. HOLDING COMPANY ACT RELEASES

AMERICAN ELECTRIC POWER COMPANY, INC.; NATIONAL FUEL GAS COMPANY;
GENERAL PUBLIC UTILITIES CORPORATION

Notices have been issued giving interested persons until March 7 to request a hearing on a proposal by the following companies filed under Release 35-24578, dated February 11: AMERICAN ELECTRIC POWER COMPANY, INC. - a registered holding company, to issue and sell to the trustee of its system employees savings plan, from April 1, 1988 to December 31, 1990, the balance of shares of common stock previously authorized to be so issued and sold; NATIONAL FUEL GAS COMPANY - a registered holding company, its subsidiary, Enerop Corporation, and Enerop's prospective partner, Metscan Technology Partners (Partnership). Under the proposal, National will assign its interests in Metscan, Inc. to Enerop, and will make a capital contribution to Enerop of up to \$800,000. Enerop will use such funds to invest in Partnership, which will develop and market certain gas meter reading technology. Partnership requests that it be declared not to be a subsidiary company of either Enerop or National; GENERAL PUBLIC UTILITIES CORPORATION (GPU) - a registered holding company, to amend its Articles of Incorporation and By-Laws to (a) provide staggered terms for the Board of Directors, and increase the minimum number of directors from four to five, (b) increase the number of authorized shares of common stock, and (c) provide for a notice period before the next annual meeting during which any shareholder proposal must be submitted. GPU proposes to solicit proxies for its May 2, 1988 annual meeting of shareholders in connection with these proposed amendments to its Articles and By-Laws.

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-87-50) to clarify index advice procedures and to require that such advice forms be submitted for all index option contracts that are to be exercised. (Rel. 34-25321)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the New York Stock Exchange (SR-NYSE-87-46) that would extend the effectiveness of NYSE Rule 103A to March 31, 1988. (Rel. 34-25323)

NOTICE OF PROPOSED RULE CHANGE

The Philadelphia Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-Phlx-87-38) relating to specialist privileges in any extended trading segment or if additional option types are listed for allocation. Publication of the proposal is expected to be made in the Federal Register during the week of February 22. (Rel. 34-25335)
