ALLAN S. MOSTOFF APPOINTED DIRECTOR OF POLICY STUDIES

LIBRARY The SEC today announced the appointment of Allan S. Mostoff as Director of Policy Studies. Mr. Mostoff, 43, served as Director of the Commission's Division of Investment Management Regulation from 1972 to the present. He joined the Commission's staff in 1962 from the private practice of law, and since that time has held positions of increasing responsibility.

In his new position, Mr. Mostoff will direct major studies focusing on significant policy issues facing the Commission, including a study of financing for small companies and new ventures, and a study to determine the nature and extent of information on the holdings and trading of institutional investors which the Commission should require to be reported pursuant to Section 13(f) of the Securities Exchange Act of 1934, as amended. In addition, he will coordinate the Commission's response to issues arising from the increasing internationalization of the securities markets and will serve as Commission liaision with international organizations and foreign securities regulatory bodies.

Anne P. Jones, Associate Director of Investment Management Regulation, has been named Acting Director of that Division.

RODERIC L. WOODSON APPOINTED FREEDOM OF INFORMATION ACT OFFICER

> James C. Foster, Director of the Office of Reports and Information Services has announced the appointment of Roderic L. Woodson as Freedom of Information Act (FOIA) Officer. As FOIA Officer, Mr. Woodson will make final determinations on initial requests to the Commission for access to or copies of records under the FOIA. Mr. Woodson joined the Commission's staff as an Attorney Adviser in October 1973 in the Division of Corporation Finance after having received a B.A. degree in Political Science from Pennsylvania State University in 1969 and a J.D. degree from Howard University School of Law in 1973. He is a member of the Pennsylvania and Georgia Bars.

REGULATION B EXEMPTIONS OF DALTEX PETROLEUM CORPORATION AND HYCO OIL, INC. TEMPORARILY SUSPENDED

> The Commission has issued an order temporarily suspending the Regulation B exemptions from registration under the Securities Act of 1933 with regard to the public offering of fractional undivided interests in oil and gas leases in the offering of DalTex Petroleum Corporation (Rel. 33-5670) and Hyco Oil, Inc. (Rel. 33-5669).

TRADING SUSPENSIONS

TRADING SUSPENDED IN ALTA GOLD CORPORATION

> The SEC has announced the temporary suspension of over-the-counter trading in the securities of Alta Gold Corporation, a Utah corporation located in Denver, Colorado, for the single ten-day period beginning on January 13 and terminating at midnight (EST) on January 22, 1976. The suspension was initiated because of Alta's present inability to identify its stock that should not be transferred absent registration under the Securities Act of 1933, as amended, and because current accurate information concerning assets of Alta is unavailable to the public. APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposal filed by The Chicago Board Options Exchange, Incorporated to commence trading in options for which the underlying security is the common stock of Boise Cascade Corporation. (Rel. 34-12005)

On December 19, 1975, proposed changes in the rules of Stock Clearing Corporation were filed pursuant to Rule 19b-4. The filing concerned the processing of odd-lot NYSE transactions. On January 6, 1976, the previous filing was replaced on a new filing, which incorporated an amendment to previously-proposed new Rule 39.
