#### U.S. SECURITIES AND EXCHANCE COMMISSION

SMW SECURITIES, INC. SANCTIONED

Pursuant to an offer of settlement submitted by SMW Securities, Inc. of Jackson, Mississippi, the Commission has entered an order delaying the effective date of registration of SMW Securities, Inc. as a broker-dealer until May 26, 1976. The offer was made without admitting or denying the allegations in the Commission's order for proceedings. The sanctions were based upon findings pursuant to the offer of settlement that SMW Securities, Inc. wilfully violated the registration requirements for brokerdealers and the bookkeeping and supplemental reporting requirements of the Securities Exchange Act of 1934. WILLIAM C. KRETSCHMER, JR. SUSPENDED

The Commission has suspended William C. Kretschmer, Jr. formerly a vice-president or and a registered representative with Chartered New England Corp., of New York City, from association with a broker or dealer for six months, provided that after six months he may associate with a broker or dealer in a non-supervisory capacity upon a showing to the Commission of adequate supervision, and has barred him from association with a broker or dealer in a supervisory capacity, provided that after eighteen months he may apply to the Commission to be so associated. The sanctions were based on findings that Kretschmer violated the antifraud provisions of the securities laws in connection with the securities of Audio Media Corp. The Commission's action was taken pursuant to the offer of settlement of Kretschmer, in which the respondent, without admitting or denying the charges against him, consented to the above findings and sanctions. #### **COMMISSION ANNOUNCEMENTS**

ANNOUNCEMENT OF ESTABLISHMENT OF ADVISORY COMMITTEE ON REPLACEMENT COST IMPLEMENTATION

In Securities Act Release No. 5695 (Accounting Series Release No. 190) dated March 23, 1976, the SEC announced amendments to Regulation S-X requiring disclosure of certain replacement cost data. In that same release the Commission announced its intention "to appoint an advisory committee composed of persons working with the problems of implementation to meet on a regular basis with the staff of the Commission to consider problems raised by registrants in complying with the [replacement cost] rule."

The Commission has now established such an advisory committee. The committee is expected to meet approximately six to eight times prior to the first date replacement cost data are required to be included in a document filed with the Commission. The first meeting of the committee will be held on May 18, 1976 beginning at 9:30 a.m. in Room 776 at the Commission's office in Washington, D.C. Meetings of the committee will be open to the public.

The committee's objectives are to advise the Chief Accountant of the Commission on various difficult, complex and technical questions concerning implementation of the new replacement cost rule. The Chief Accountant will be particularly interested in the committee's views on the conceptual and empirical problems of replacement cost measurement and the types of supplemental disclosures which are appropriate to ensure that complete and meaningful information is provided financial statement readers.

In order to utilize effectively the talents and knowledge of the members of the advisory committee the Commission is encouraging registrants, accountants and others to submit implementation questions to the Chief Accountant as they arise. These questions will be distributed to the advisory committee members approximately two weeks in advance of a scheduled meeting and will be the basis for a substantial portion of the discussion at the meetings. Copies of the questions submitted to the members of the advisory committee will be made publicly available at the Commission's public reference room. Subsequent to the meetings the Chief Accountant will issue a staff accounting bulletin wherein his recommended solution to the implementation questions will be described.

Implementation questions may be submitted to the Chief Accountant in any format; however, the staff would prefer a format similar to that employed in the staff accounting bulletins, i.e., a statement of the facts, the question (or possibly a series of questions related to the same facts) and the writer's recommended solution (or a discussion of the various solutions which seem possible). Regardless of the format employed writers should take care to ensure that the facts and questions are stated with sufficient specificity that a meaningful recommendation can be made.

There may be instances wherein registrants or others will wish to raise questions or make oral presentations to the committee at its meetings. This will be acceptable provided a written request to make such a presentation is received by the Chief Accountant at least three weeks in advance of the scheduled meeting and the request describes the nature of the presentation.

In Securities Act Release No. 5695 the Commission stated its belief "that it would be useful for industry groups and associations to consider specialized problems in the application of replacement cost concepts to their areas of interest." If such groups and associations are able to develop recommended uniform approaches to the implementation of replacement cost for their industry it would be beneficial if such groups could meet with the committee to discuss the recommended approaches.

### TRADING SUSPENSIONS

TRADING SUSPENSION OF PRESLEY COMPANIES CONTINUED

The SEC announced the continuing temporary suspension of exchange and over-the-counter trading for the ten-day period beginning on May 4 and continuing through May 13, 1976 of the securities of Presley Companies, a California corporation located in Newport Beach, California.

The Commission in ordering ten day suspensions is fully aware of the potential hardships which this decision imposes on certain holders of securities which have been suspended. However, the circumstances which caused the Commission initially to suspend the stock of Presley Companies on March 25, 1976, following a rapid increase in the price of Presley stock amid conflicting reports of the company's arrangment whereby it acquired the licensing rights to a device which purportedly produces hydrogen gas from tap water have not as yet been adequately clarified and accordingly, the Commission deems it appropriate for the further protection of investors and in the public interest to extend the trading suspension through May 13.
