COMMISSION ANNOUNCEMENTS

NOTICE OF PUBLICATION OF STAFF ACCOUNTING BULLETIN NO. 8

U.S. SECURITIES AND EXCHANGE COMMISSION

The Division of Corporation Finance and the Office of the Chief Accountant announced the publication of Staff Accounting Bulletin No. 8 which deals with the following:
(1) Sundry changes and corrections to Staff Accounting Bulletin No. 1; (2) "Free distributions" of common stock by foreign companies; (3) Presentation of the partnership equity accounts and results of operations of limited partnerships; (4) Accounting for tax benefits of loss carryforwards; (5) Accounting for employee stock ownership trusts (ESOT's); (6) Prior period adjustments; (7) Disclosure of components of income tax expense; and (8) Disclosure of amounts receivable from underwriters, promoter, directors, officers, employees and principal holders of equity securities. (SAB-8)

COURT ENFORCEMENT ACTIONS

LIMITED RECEIVER APPOINTED FOR VTR, INC.

The SEC announced that on May 26 the Honorable Oliver Gasch, U.S. District Judge for the District of Columbia appointed Burton R. Tauber, Esq. of 400 Park Avenue, New York, N.Y., as limited receiver for VTR, Inc. (VTR) pursuant to the Court's order of April 29 and the stipulation between the parties of May 20. According to such order and stipulation, Tauber is charged with overseeing the prompt preparation and filing of certain of VTR's delinquent annual reports on Form 10-K, the required amendments to VTR's annual report on Form 10-K for its fiscal quarter year-ended December 31, 1973, and any other periodic reports coming due during his incumbency. Tauber is also to make recommendations to the Court and the Commission for a program to assure VTR's future compliance with the company's filing requirements under Section 13(a) of the Securities Exchange Act of 1934. According to the May 26 order, Tauber is to be compensated for such services from the fines paid and to be paid into the Registry of the Court by VTR and David E. Jordan, VTR's president, in satisfaction of judgments rendered and to be rendered by the Court to remedy civil contempt by VTR and Jordan. The remainder of any fines paid into the Registry is to be turned over to the U.S. Treasury. Judge Gasch entered two judgments of fine on March 3 and April 29, when apprised to VTR's continued failure to file the abovementioned reports in violation of Judge Gasch's final judgment of permanent injunction ordering such compliance.
