CIVIL PROCEEDINGS

JOHN S. DALY, JR. ENJOINED

The Boston Regional Office announced that on March 9 the Honorable Walter J. Skinner in the U.S. District Court for the District of Massachusetts entered an Order of Permanent Injunction against John S. Daly, Jr. Without admitting or denying the allegations of the Commission's complaint, Daly consented to the entry of a Permanent Injunction enjoining and restraining him from aiding and abetting violations of Section 31(a) of the Investment Company Act of 1940 and Rule 31a-1 thereunder, and from violating Section 34(a), 34(b) and 37 of the Investment Company Act of 1940.

The Commission's complaint alleges that Daly and others, over a period of approximately ten years and while employed by New England Merchants Bank, aided and abetted several investment companies (the Funds), which received custodial and shareholder recordkeeping services from New England Merchants Bank, in failing to maintain and keep current required books and records. Further, the Commission's complaint alleges that Daly and others altered certain books and other documents of the Funds by incorrectly recording (1) sales and redemptions of the Funds' securities, (2) the number of shares held by shareholders of the Funds and (3) the dates, number of shares and prices of shares in certain accounts. Also alleged in the complaint is that Daly and others made untrue statements of and omitted to state material facts in certain records required to be kept by registered investment companies.

With respect to Daly, the complaint alleges that he unlawfully and willfully converted to his OWn use and embezzled moneys, funds, securities, credits, property and assets of four investment companies. (SEC v. Edward J. Falvey, et al.) (LR-9619)

PLAN APPROVED FOR DISTRIBUTION OF TRANSFER RECORDS HELD BY FIRST INDEPENDENT STOCK TRANSFER AGENT, INC.

The Denver Regional Office announced that on October 2, 1981, the Honorable Richard P. Christensen, Court appointed receiver for First Independent Stock Transfer Agent, Inc.
