ADMINISTRATIVE PROCEEDINGS

PUBLIC ADMINISTRATIVE PROCEEDINGS, FINDINGS AND ORDER INSTITUTED AGAINST ANDE SECURITIES CORPORATION AND ANGELA DEANE

The Commission announced the institution of public administrative proceedings under the Securities Exchange Act of 1934 naming as respondents ANDE Securities Corporation (Registrant), a registered broker-dealer in New York City, and Angela Deane, president and registered principal of Registrant. The Order for Proceedings alleges that the respondents wilfully violated the antifraud provisions and aided and abetted violations of the credit extension provisions of the Exchange Act in connection with the purchase and sale of securities by customer accounts maintained by Registrant and another broker-dealer. The Order further alleged the entry by the U.S. District Court for the Southern District of New York of permanent injunctions by consent against Registrant and Deane [SEC v. Murdock, et al., 81 Civil 4923, S.D.N.Y.] and the entry by the U.S. District Court for the Central District of California of a permanent injunction by consent against Deane [SEC v. Zukor, et al., 80 Civil 4663, C.D. Cal.].

Simultaneously, the Commission accepted an Offer of Settlement in which the respondents, without admitting or denying the allegations, except as to the entry of the injunctions noted above to which respondents admitted, consented to the entry of Findings and an Order by the Commission suspending Registrant's registration as a broker-dealer and Deane from association with any broker or dealer for one year. The Order also provides that following 90 days of this suspension, Deane may become association with a broker-dealer and the registration of Registrant as a broker or dealer shall remain in effect subject to certain conditions upon the operations of Registrant and Deane. NOTICE OF EFFECTIVENESS OF PROPOSED RULE CHANGES

Rule changes filed by the Midwest Securities Trust Company, pursuant to Rule 19b-4, have become effective in accordance with Section 19(b)(3)(A) of the Securities Exchange Act of 1934: (SR-MSTC-82-4) which would allow MSTC to amend its Dividend Reinvestment Program and procedures. The proposed rule change restricts the number of shares eligible to participate in MSTC's Dividend Reinvestment Program and prorates the number of shares credited to a participant's account as a result of dividend reinvestment only to those shares held in MSTC's nominee name, Kray & Co. (Rel. 34-18663); and (SR-MSTC-82-6) which enables MSTC to disburse to its participants cash dividends and bond interest payments on payment date, rather than on the day after payment date, which was the previous practice.
