ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

CENTRAL FUNDING, INC. AND MICHAEL J. COUR SANCTIONED

In connection with previously instituted administrative proceedings, the Commission has accepted the Offer of Settlement submitted by Central Funding, Inc., a registered investment adviser previously located in Branson, Missouri, whereby its registration as an investment adviser has been revoked. The Commission has also accepted the Offer of Settlement submitted by Michael J. Cour of Joplin, Missouri who was the president, treasurer, sole director and sole shareholder of Central Funding. In accordance with his Offer of Settlement, Cour has been barred from association in any capacity with any broker or dealer, investment company, investment adviser or municipal securities dealer.

In their Offers of Settlement, Central Funding and Cour consented, without admitting or denying, to findings that on July 27, 1981, Cour, a person associated with Central Funding, was convicted in the Circuit Court of Taney County, Missouri of three felonies based on his plea of guilty to three counts of a seven-count Amended Felony complaint. The felony counts to which Cour pleaded guilty were transacting business as an investment advisor when not subject to an effective registration, taking custody of funds of a client while acting as an investment advisor, and investment advisory fraud. These matters involved conduct which arose out of Cour's association with Central Funding and involved, in part, misappropriation to client funds. Further, these matters involved conduct specified in Sections 203(e) and 203(f) of the Investment Advisers Act of 1940 as grounds for the imposition of sanctions. (Rel. IA-815)

TRADING SUSPENDED IN FRONTIER RESOURCES CORPORATION

The Commission announced the temporary suspension of over-the-counter trading in the securities of Frontier Resources Corporation, a Nevada corporation with offices located in Irving, Texas, for the ten-day period beginning at 10:45 a.m. on August 5 and terminating at midnight (EST) on August 14, 1982.

The Commission suspended trading in the securities of Frontier because of questions concerning recent unusual market activity in its securities and because of an apparent lack of adequate and accurate public information about the company, including, but not limited to, disclosures by Frontier concerning its interest in and description of its principal asset, a 1,920-acre oil and gas lease, purportedly located in the Yates Field, Crockett County, Texas.
