SUMMARY OF MEETING:

The meeting was an introductory courtesy call requested by Bill Wood of U.S. PIRG.

Mr. Wood provided Commissioner Moore with a packet of information on U.S.PIRG and explained the structure and background of the PIRG organization.

Mr. Wood explained that an important PIRG objective is to promote consumer product safety through influencing legislation and surveying the marketplace nationwide through their local state PIRG groups for hazardous toys. PIRG then provides this information to the Commission staff for investigation in advance of their holiday press conference.

Mr. Wood stated that U.S. PIRG is supportive of the Commission and its efforts, although they do not always agree with Commission actions. As an example, PIRG believes that the ATV corrective action taken by the Commission is inadequate. PIRG believes that injuries and deaths are continuing at an unacceptable level.

The meeting was concluded with Mr. Wood expressing PIRG's continued support of the Commission's goal.
