

SUMMARY OF MEETING:

The mission of the Bedclothes Task Force is to assist in the research of bedding flammability. The Task Force is specifically assisting the California Bureau of Home Furnishings (CBHF) to address bedding flammability in a manner that is reasonable and transparent. California legislation, AB 603, requires CBHF to address bedding flammability.

The October 22, 2003 meeting of the Task Force took place in Tampa, Florida. The purpose of the meeting was to continue developing the draft TB 604 rulemaking language for the bedclothing test standard. After welcoming remarks and introductions, Lynn Morris, Bureau Chief, provided an update of TB 603 and confirmed the implementation date of January 2005. Instead of filing for an exemption for preemption, CBHF has filed comments with CPSC regarding adopting TB 603.

John McCormack, CBHF, provided an update on the latest draft of TB 604, noting the changes and additions of the May 2003 draft. A review of the latest test data was provided. The group discussed several issues with the standard including weight loss requirements, refurbishment procedures, conditioning options, and standard sheeting specifications. The group discussed conducting further studies and obtaining additional test data to assist in resolving several of the group's concerns.

CBHF hopes to open rulemaking in December.
