HIGHLIGHTS OF MEETING: The purpose of this meeting was to discuss the need for a voluntary consensus standard for fire blankets intended for residential use. Issues discussed included type of material, size requirements, labeling, and appropriate product applications. The group decided to establish an ASTM Subcommittee to develop a safety standard on fire blankets for residential use. Subsequent to the meeting, ASTM advised this subcommittee (ASTM F15.46) would be under the jurisdiction of the ASTM F15 Committee on Consumer Products.
