SUMMARY OF MEETING:

Mr. O'Neill told the Commissioner that NFPA was forming a Children's Safe Sleepwear Coalition. Its purpose was to have CPSC revisit the children's sleepwear issue. They were also pledged to monitor burn incidents.

The Commissioner indicated that he was glad to hear they would be doing monitoring and that our staff would be doing that as well.

Mr. O'Neill also indicated a concern about the sleepwear industry reneging on their promise to mount an information and education campaign. The Commissioner indicated that he hoped this was not the case and hoped the industry would follow through on the campaign.

Mr. McGuire questioned whether garments worn by children will really be tight fitting given the use of hand-me-downs and parents buying larger sizes so children can wear them longer. He also questioned the usefulness of hang tags and other educational efforts in changing buying patterns.

Mr. O'Neill said the Coalition had visited with the Congressional Fire Caucus to express their concerns about the sleepwear amendments. He also stated that a press conference was going to be held in February to kick off their national campaign.

Mr. O'Neill gave out copies of an article entitled "Children's Sleepwear: Relaxation of the Consumer Product Safety Commission's Flammability Standards" printed in the September/October 1997 issue of the Journal of Burn Case and Rehabilitation (contact John O. Kucan, M.D., SIU School of Medicine, Institute for Plastic and Reconstructive Surgery, 747 No. Rutledge Street, Springfield, Illinois 62794, for information on how to obtain a copy of this article) on the sleepwear issue.

Commissioner Moore said he wouldn't hesitate to revisit the sleepwear issue if the data existed to indicate such was necessary. He said he welcomed NFPA's interest in this area.

Mr. O'Neill indicated there was confusion as to the current state of the sleepwear regulations. Ms. Neily stated that sleepwear could be made to comply with the old flammability standards, or be made in cotton if it met the tight-fitting requirements of the amendments which went into effect last January. And, until June of 1998, long-underwear garments which are the subject of an agency stay of enforcement, could still be marketed, as long as they were marketed as underwear and not sleepwear.

The NFPA representatives thanked the Commissioner for his time on this matter.
