# REMEMBER

## TYPES OF FRAUD

- Using another person's identity (e.g., name, social security number) to work and/or file fraudulent UI claims
- Allowing another person to use your personal identification to work and/or file fraudulent UI claims
- Cashing someone else's UI checks
- Working while collecting UI benefits, and not reporting hours of work and earnings to EDD
- Aiding someone in filing a fraudulent UI claim
- Falsifying information or failing to disclose information (e.g., failing to report school attendance while collecting UI benefits)
- Fabricating work search efforts
- Failing to report other types of compensation (e.g., pension, Workers' Compensation benefits, etc.)
- Failing to report being unable and unavailable to work (e.g., ill or injured, out of the area, on vacation, etc.) and collecting UI benefits
- Failing to report refusals of work
- Falsifying or failing to disclose reason for no longer working

You are a very important source of information about claimants and employers committing fraud.

### HOW TO REPORT FRAUD

If you think individuals are committing UI fraud, please report it online via a secure connection at **www.edd.ca.gov** or call our toll-free fraud hotline at **1-800-229-6297**. All allegations of fraud are taken seriously, and you will remain anonymous if you prefer. Please include as much of the following information as possible:

- ☑ Who is committing fraud (other names used)?
- ☑ What is their social security number?
- ✓ What is their date of birth or approximate age?
- ☑ What is their address?
- ☑ What is their telephone number/e-mail address?
- What type of fraud are they committing? (Working? Self-employed while collecting UI benefits? Not looking for work? Collecting UI benefits using someone else's social security number?)
- ☑ When did they start doing this?
- ☑ Where do they receive their benefit checks?
- ✓ Where do they cash their benefit checks?
- ✓ If they are working, what is the employer's name, address, and telephone number?
- ✓ What is your name, address, e-mail address, and telephone number? (optional)
