#### REPORTING INJURIES

Please remember to notify NDC of any injuries or conditions, work or non-work related, requiring anything more than basic first aid. The NOAA Dive Regulations (NAO 209-123, Section-5.02), Reporting, Investigating, and Reviewing Diving Incidents and Accidents states that " ... All work-related injuries are to be promptly reported in compliance with Department of Commerce (DOC) and NOAA policies. Whether such injuries are the direct or indirect result of diving, they must be reported in accordance with procedures outlined below. Examples of reportable diving injuries include: (a) fatalities; (b) injuries requiring recompression therapy (e.g., decompression sickness and lung overexpansion injuries); and c) injuries, whether occupational or non-occupational, requiring hospitalization or that otherwise may affect an individual's fitness to dive (questions concerning the requirement for reporting of an injury should be referred to the NDC). UDSs & ship Divemasters - A reminder that all "NOAA-certified divers shall undergo yearly refresher training in oxygen administration, recognition and treatment of diving accidents and injuries, dive rescue, decompression tables, and in-water diving emergency skills." Much of this training can be conducted by viewing the NOAA Diving Program Refresher CD. If you are no longer (or were never) in possession of this CD, please contact Laurie Barber at the Diving Center. A CD will be prepared for your ship/unit and mailed to you. You may, of course, also prepare your own refresher materials for your divers.

### ANNUAL MEDICAL HISTORY

Annual Medical History Report forms (NOAA Form 56-59) are due from all NOAA divers age 59 and younger by March 01 of each new calendar year. Forms may be faxed or mailed directly to the NOAA Diving Center, and are available online from the NDC web site or by request from NDC. should note any health changes from their last medical history form submitted to NDC. These forms do not require the signature of a physician nor anyone else besides the diver.

Failure to submit this form by March 01 will result in the suspension of the diver's NOAA cert ification.

# **UNIT DIVING INSPECTIONS**

Annual dive locker inspections are required by NAO 209-123 (NOAA Dive Regs). Unit Diving Inspection Checklists, used to conduct these inspections, are important to better ensure that unit/ship dive lockers are evaluated with a critical eye with regard to equipment condition and maintenance, organization, resource availability, etc. Completed checklists were due from all units/ships to their LODO/ FDO by January 15.

Units/ships failing to submit dive locker inspections to their LODO/FDO by March 31, 2004 will result in the suspension of diving certifications for all divers in that unit. Inspection checklists are also available online at the NDC web site.
