"GRAIN INSPECTION FEES"

EFFECTIVE DATE: FEBRUARY 1, 2007. " FEDERAL GRAIN INSPECTION SERVICE (FGIS) MUST APPROVE ALL FEES FOR OFFICIAL SERVICES AND OA'S WILL ASSESS ONLY THOSE FEES APPEARING ON THEIR CURRENT APPROVED FEE SCHEDULE."

REGULAR HOURS: 08:00 TO 16:00 MONDAY THROUGH FRIDAY EXCEPT HOLIDAYS. "OFFICIAL SERVICES NOT COVERED BY FEES WILL BE CHARGED AT THE APPLICABLE HOURLY RATE .

REGULAR HOURLY RATE/STANDBY RATE: \$12.00 PER MAN HOUR.

HOLIDAY RATE/OVERTIME RATE: \$18.00 PER MAN/HR FOR SATURDAY, SUNDAY AND OTHER THAN REGULAR WEEKDAY HOURS ASSESSED IN ADDITION TO OTHER FEES IN QUARTER HOUR INTERVALS. HOLIDAYS INCLUDE NEW YEARS, MEMORIAL DAY, JULY 4TH, LABOR DAY, THANKSGIVING AND CHRISTMAS.

TRAVEL TIME: ASSESSED PER MAN HOUR AT APPLICABLE HOURLY RATE
MILEAGE: THE IRS STANDARD MILEAGE WILL BE ASSESSED PER MILE. (PRO RATED WHEN APPLICABLE) ANY CHANGE TO THE MILEAGE RATE IS EFFECTIVE WHEN THE IRS CHANGES THEIR RATE.

ONSITE LAB STAFFING: APPLICABLE HOURLY RATE CHARGED PER INDIVIDUAL NECESSARY TO PERFORM THE SERVICE, MINIMUM OF ONE INSPECTOR AND ONE TECHNICIAN.

STANDBY TIME: WILL BE AVERAGED AT THE RATE OF 1 RAILCAR, 3 TRUCKS, OR 3 SUBMITTED SAMPLES PER MAN/HR EXCLUDING TRAVEL TIME. IF A FACILITY FAILS TO BEGIN WORK WITHIN ONE HALF HOUR OF ARRIVAL OF OFFICIAL PERSONAL ,STANDBY TIME WILL BE ASSESSED.
