## OFFICIAL INSPECTION FEES

EFFECTIVE DATE: January 1, 2006 Federal Grain Inspection Service (FGIS) must approve all fees for official services and official agencies will assess only fees appearing on their current fee schedule.

**REGULAR HOURS**: 8:00 a.m. to 5:00 p.m. Monday through Friday *EXCEPT* holidays.

**HOLIDAYS:** New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eye Day, Christmas Day.

## **SAMPLING REGULAR HOURLY RATE:** Mechanical Diverter (per man-hour) \$12.00

MILEAGE RATE: \$.35 per mile to service points outside Marion County - prorated when possible.

**OVERTIME HOURLY RATE**: One and one-half time regular hourly rate assessed in half-hour, intervals, plus inspection fees, for other than regular weekly hours and Saturday for all services requested.

SUNDAY AND HOLIDAY HOURLY RATE: Double the regular hourly rate will be assessed in half-hour intervals, plus inspection fees, for Sunday and Holidays for all services requested.

MINIMUM FEE: A four-hour minimum fee will be assessed whenever a service request is canceled after personnel have departed to perform the service, plus mileage. Travel time will not be assessed when the minimum fee is applied.

**STANDBY TIME:** Standby time at the applicable hourly rate will be assessed for applicant caused delays.
