### Schedule of Inspection Fees and Charges

Effective date: October 1, 2008

Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current approved fee schedule.

Regular Hours: 0700 to 1500 Monday through Saturday except holidays \$15.00 per hour per individual shall be assessed in  $\frac{1}{4}$  hour intervals for all service where an hourly rate is indicated.

Overtime: Sunday and Holiday Hourly Rate: \$22.50 per hour, the rate assessed for overtime and holiday hours will be in addition to the normal unit fee. Hourly rates will be assessed in  $\frac{1}{4}$  hour increments.

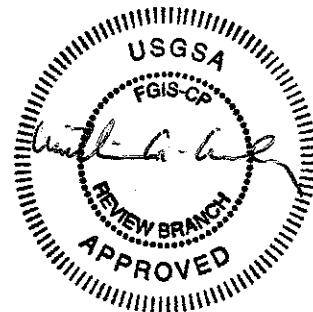
Holidays: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day.

Mileage and Travel Time: The IRS standard mileage rate will be assessed per mile for actual miles traveled. Any change to the mileage rate is effective when the IRS changes their standard mileage rate, (prorated when possible). Travel time will be assessed portal-to-portal at the applicable hourly rate. Except no travel time will be assessed for barge inspection, when loading is completed in one trip to elevator.

Standby Time: Standby time will be assessed at the applicable hourly rate whenever an applicant causes a delay and does not release the service representative to perform other duties.

Official Commercial Inspections are available upon request and fees will be negotiated on a case-by-case basis.

The unit fees do not include state tax, if applicable.



**Minimum Fee:** A minimum of 5 containers per trip, plus the unit fees and hourly rate, as applicable.
